# CITY OF GLEN COVE MINUTES OF THE CITY COUNCIL MEETING

**OCTOBER 12, 2021** 

Mayor Tenke called the meeting to order at 7:32 p.m., and Donna Marino lead those assembled in the Pledge of Allegiance.

PRESENT: Mayor Tenke, Councilpersons Silverman, Fugazy Scagliola, Perrone, Lupenko Ferrante, and Stevenson-Mathews.

ABSENT: Councilman Totino.

ALSO PRESENT: City Clerk Charon and City Attorney Kalnitsky.

Mayor Tenke called for a moment of silence in remembrance of the passing of Carmello Carter and his father, Troy Carter.

Mayor Tenke issued a citation to Donna Marino in recognition of her recent retirement and in appreciation for her service to the City.

Mayor Tenke asked the City Clerk to read the announcements, and the City Clerk gave notice of upcoming events including Long Island Drive Electric's educational workshop on electric vehicles, Glen Cove Care's and Glen Cove Beautification's annual tulip planting, the Police Department's Shed Your Meds Day and the Glen Cove Fire Department's Annual Open House. Also announced was the Nassau County Early Voting schedule and that the next Pre-council Meeting will be held at the Ferry Terminal.

Mayor Tenke opened Public Hearing 2A to hear comments on the proposed 2022 Budget.

Mayor Tenke noted that Public Hearing 2A would be kept open until the October 26, 2021 meeting at which time it is anticipated that the City Council will vote on the matter.

Mayor Tenke made a motion to adopt minutes of the September 28, 2021 meeting. Councilman Stevenson-Mathews seconded the motion. The motion unanimously carried with Councilman Perrone abstaining, and minutes of the September 28, 2021 meeting were adopted.

Mayor Tenke made a motion to adopt the warrants. Councilman Perrone seconded the motion. The motion unanimously carried, and the warrants were adopted.

## RESOLUTION OF THE GLEN COVE COUNCIL CERTIFYING THE LOCAL ADJUSTMENTS TO THE ADJUSTED BASE PROPORTIONS OF THE HOMESTEAD AND NON-HOMESTEAD CLASSES FOR THE CITY OF GLEN COVE FOR TAX PURPOSES PURSUANT TO ARTICLE 19 OF THE REAL PROPERTY TAX LAW

WHEREAS, by Local Law No. 1-2001, the Glen Cove City Council adopted the provisions of Section 1903 of the Real Property Tax Law relating to the establishment and certification of the local adjustments to the adjusted base proportions of the homestead and non-homestead classes; and

WHEREAS, the homestead locally adjusted base proportion of the City of Glen Cove for the assessment roll of 2021 and the tax year 2022 has been determined to be 74.365146 present pursuant to Section 1903 of the Real Property Tax Law; and

WHEREAS, the non-homestead locally adjusted base proportion of the City of Glen Cove for the assessment roll of 2021 and the tax year 2022 has been determined to be 25.634854 percent pursuant to Section 1903 of the Real Property Tax Law; and

**NOW, THEREFORE, BE IT RESOLVED**, that the Glen Cove City Council does hereby certify as follows:

- 1. The locally adjusted base proportion for the homestead class shall equal 74.365146 percent for the assessment roll of 2021 and the tax year 2022;
- 2. The locally adjusted base proportion for the non-homestead class shall equal 25.634854 percent for the 2021 assessment roll and the tax year 2022.
