### MINUTES OF THE

#### CITY COUNCIL MEETING

#### **OCTOBER 26, 2021**

Mayor Tenke called the meeting to order at 7:37 p.m., and U.S. Marine Corps. Sergeant Evelyn M. Kandel lead those assembled in the Pledge of Allegiance.

PRESENT: Mayor Tenke, Councilpersons Silverman, Totino, Perrone, Fugazy Scagliola, Lupenko Ferrante, and Stevenson-Mathews.

ABSENT: None.

ALSO PRESENT: City Clerk Charon and City Attorney Kalnitsky.

Mayor Tenke issued a citation to Sergeant Evelyn M. Kandel in recognition of her exceptional leadership and devoted service in the Marine Corps from 1951 to 1953 and in recognition of her Living Legend Award from the Military Women's Memorial. Mayor Tenke noted that Sergeant Kandel's exemplary service helped pave the way for thousands of women to follow in her footsteps and to serve the nation in peace and war.

Mayor Tenke asked the City Clerk to read the announcements, and the City Clerk gave notice that the early voting conducted by the Nassau County Board of Elections will continue through Sunday, October 31, 2021, that the first Pre-Council Meeting in November will be the day after Election Day on Wednesday, November 3, 2021, and that the Children's Halloween Parade will take place on Saturday October 30, 2021.

Mayor Tenke opened Public Hearing 2A to hear comments on the proposed 2022 Budget.

Mayor Tenke made a motion to close Public Hearing 2A. Councilman Perrone seconded the motion. The motion carried unanimously, and Public Hearing 2A was closed.

Mayor Tenke made a motion to adopt the minutes of the October 12, 2021 meeting. Councilman Stevenson-Mathews seconded the motion. The motion carried unanimously, and the minutes of the October 12, 2021 meeting were adopted.

# JOINT MUNICIPAL COOPERATIVE BIDDING PROGRAM

WHEREAS, various educational and municipal corporations located within the State of New York desire to bid jointly for generally needed services and standardized supply and equipment items; and

**WHEREAS**, the City of Glen Cove, an educational/municipal corporation (hereinafter the "Participant") is desirous of selectively participating with other educational and/or municipal corporations in the State of New York in joint bidding in the areas mentioned above pursuant to General Municipal Law § 119-0 and Education Law Section 1950; and

WHEREAS, the Participant is a municipality within the meaning of General Municipal Law §119-n and is eligible to participate in the Board of Cooperative Educational Services, First

Supervisory District of Suffolk County (hereinafter Eastern Suffolk BOCES) Joint Municipal Cooperative Bidding Program (hereinafter the "Program") in the areas mentioned above; and

**WHEREAS**, the Participant acknowledges receipt of the Program description inclusive of Eastern Suffolk BOCES' standard bid packet and the general conditions relating to said Program; and

WHEREAS, with respect to all activities conducted by the Program, the Participant wishes to delegate to Eastern Suffolk BOCES the responsibility for drafting of bid specifications, advertising for bids, accepting and opening bids, tabulating bids, awarding the bids, and reporting the results to the Participant.

**BE IT RESOLVED** that the Participant hereby appoints Eastern Suffolk BOCES to represent it and to act as the lead agent in all matters related to the Program as described above; and

**BE IT FURTHER RESOLVED** that the Participant hereby authorizes Eastern Suffolk BOCES to place all legal advertisements for any required cooperative bidding in Newsday, which is designated as the official newspaper for the Program; and

**BE IT FURTHER RESOLVED** that a Participant Meeting shall be held annually consisting of a representative from each Program Participant. Notice of the meeting shall be given to each representative at least five (5) days prior to such meeting; and

**BE IT FURTHER RESOLVED** that an Advisory Committee will be formed consisting of five to ten representatives of Program Participants for a term of three (3) years as authorized by General Municipal Law §119-o.2.j.

**BE IT FURTHER RESOLVED** that this Agreement with the Participant shall be for a term of one (1) year as authorized by General Municipal Law §119-o.2.j.

**BE IT FURTHER RESOLVED** that the Participant agrees to pay Eastern Suffolk BOCES an annual fee as determined annually by Eastern Suffolk BOCES to act as the lead agent for the Program in an amount not to exceed \$580 for the period July 1, 2021 to June 30, 2022.
