Mayor Panzenbeck called the meeting to order at 7:30 p.m. and asked Kennedy Hyde to lead those assembled in the Pledge of Allegiance.

PUBLIC HEARING:

A To discuss Local Law amending Chapter 252 Taxation, Article II Senior Citizens Tax Exemption, §252-16. Maximum income level.

Mayor Panzenbeck stated:

Councilwoman Silverman seconded the motion. The Motion was unanimously adopted.

Mayor Panzenbeck offered Resolution 6A and moved for its adoption.

Resolution 6A

WHEREAS, the City Council of the City of Glen Cove has determined to undertake projects listed in Schedule "I" (see attached) at a total of estimated maximum cost of \$4,938,142; and

WHEREAS, the State Environmental Quality Review Act (SEQRA) regulations found at 6 NYCRR Part 617.3(a) require that no agency may undertake, fund or approve an action until it has complied with the requirements of SEQRA; and

WHEREAS, the SEQRA regulations at 6 NYCRR Part 617.6(a) require that as soon as possible in an agency's formulation of an action it proposes to undertake it shall: (a) determine whether the action is subject SEQRA: (b) determine whether the action involves a federal agency; (c) determine whether other agencies are involved; (d) make a preliminary classification of the action; (e) determine whether a full or short form Environmental Assessment Form (EAF) will be used; and (f) determine whether the action is located in an agricultural district and complies with Subdivision (4) of Section 305 of Article 25-AA of the Agriculture and Markets Law; and

WHEREAS, 6 NYCRR 617.6(b) indicates that when a single agency is involved with respect to an action, that agency shall be the lead agency and determine the significance of the action; and

WHEREAS, the projects contained in Schedule "I" are Type II actions which do not require environmental review or the filing of an EAF; and

NOW, THEREFORE BE IT RESOLVED, that the City Council of Glen Cove hereby declares itself the lead agency; and there is no Federal or other involved agencies with respect to this action; and

BE IT FURTHER RESOLVED the City Council finds that the projects listed in Schedule "I" are Type II Actions pursuant to Article 8 of the Environmental Conservation Law (SEQRA) and 6 N.Y.C.R.R. Part 617.5(c) which require no further review.

Councilman Farnan seconded the motion. Resolution 6A was unanimously adopted.

BE IT RESOLVED, that the Glen Cove City Council authorizes the Mayor to sign Amendments No. 1 and No. 2 to the contract with Property Registration Champions, LLC, dated February 16, 2021, Amendment No. 1 providing that the fee to be collected by Property Registration Champions, LLC, from mortgagees having filed a notice of pendency in a mortgage foreclosure action, is changed from \$100 to \$75, \$37.50 of which is to be kept by Property Registration Champions, LLC and \$37.50 of which is to be paid to the City of Glen Cove, and Amendment No. 2 extending the contract until February 15, 2025.

Councilwoman Silverman seconded the motion.

The motion was unanimously adopted.

Local Law 6B

LOCAL LAW 02-2023

A LOCAL LAW AMENDING CHAPTER 252 TAXATION,
ARTICLE II, SENIOR CITIZENS TAX EXEMPTION,
§ 252-16. MAXIMUM INCOME LEVEL OF THE CITY CODE OF THE CITY OF
GLEN COVE TO INCREASE THE INCOME LEVEL, FOR PEOPLE
65 YEARS OR OLDER TO BE ENTITLED TO PARTIAL
EXEMPTION FROM TAXATION UNDER § 467 OF THE REAL
PROPERTY TAX LAW

Section 1: Authority.

This local law is enacted in accordance with Municipal Home Rule Law Section 10(c)(1).

Section 2: Legislation:

BE IT ENACTED as follows:

The City Council hereby makes the following amendment to Chapter 252, Article II, Taxation, § 252-16, of the City Code of the City of Glen Cove:

§ 252-16 Maximum income level

AS EXISTS:

The maximum income level for the fifty-percent exemption is established at \$24,000, to include the sliding-scale option.

TO READ:

The maximum income level for the fifty-percent exemption is established at \$30,000, to include the sliding scale option.

*This Local Law shall take effect immediately upon filing with the Secretary of State.

LOCAL LAW 03-2023

A LOCAL LAW AMENDING CHAPTER 252, TAXATION, ARTICLE IX, PARTIAL TAX EXEMPTION FOR VOLUNTEER FIRE FIGHTERS AND AMBULANCE WORKERS, §252-30 EXEMPTION GRANTED, AND § 252-31, LONGEVITY EXEMPTION, OF THE CITY CODE OF THE CITY OF GLEN COVE PURSUANT TO § 466-a OF THE REAL PROPERTY TAX LAW

Section 1: Authority.

This local law is enacted in accordance with Municipal Home Rule Law Section 10(c)(1).

Section 2: Legislation:

BE IT ENACTED as follows:

The City Council hereby makes the following amendments to Chapter 252, Taxation, Article IX, Partial Tax Exemption for Volunteer Fire Fighters and Ambulance Workers, § 252-30, Exemption granted, and § 252-31, Longevity Exemption, of the City Code of the City of Glen Cove:

§ 252-30 Exemption granted

AS EXISTS:

The City Council of the City of Glen Cove hereby adopts § 466-c of the Real Property Tax Law, authorizing a partial exemption from real property taxation for properties owned by volunteer fire fighters and ambulance workers.

TO READ:

Pursuant to Real Property Tax Law § 466-a, Subdivisions 1 and 2, the City Council of the City of Glen Cove hereby provides that the primary residence of an enrolled member of a volunteer fire company, fire department or incorporated voluntary ambulance service in the City of Glen Cove is exempt from taxation to the extent of ten percent of the assessed value of such property for city purposes, exclusive of special assessments, provided the applicant has been certified as an enrolled member of a volunteer fire company, fire department or incorporated voluntary ambulance service, as determined by the City of Glen Cove, for a period of two years.

§ 252-31 Longevity exemption

AS EXISTS:

A longevity exemption is hereby granted for volunteer fire fighters and ambulance workers who have accrued more than 20 years of active service, per § 466-c, Subdivision 3, of the Real Property Tax Law.

TO READ:

Pursuant to Real Property Tax Law § 466-a, Subdivision 3, the City Council of the City of Glen Cove hereby provides that the primary residence of an enrolled member of a volunteer fire company, fire department or incorporated voluntary ambulance service in the County of Nassau is exempt, for the member's lifetime, from taxation to the extent of ten percent of the assessed value of such property for city purposes, exclusive of special assessments, provided the applicant has been certified as an active member of a volunteer fire company, fire department or

incorporated voluntary ambulance service in the County of Nassau, as determined by the City of Glen Cove, for a period of twenty years.

*This Local Law shall take effect immediately upon filing with the Secretary of State.

Ordinance 6D

BE IT ORDAINED, that the City Council hereby authorizes to issue serial bonds in an amount not to exceed \$4,938,142, to fund various capital improvements and purchase of equipment.

BE IT RESOLVED, that the City Council hereby authorizes amending Resolution 6B, adopted March 14, 2023, as it relates to license agreement with Eastern Star Cruises, Inc., replacing "use of one (1) slip at the most western end" with "use of the eastern-most landing/boarding area".

BE IT RESOLVED, that the City Council hereby authorizes the Mayor to approve a change order from Forenet Inc., requiring additional specialty equipment usage for the installation of the driving range poles at Glen Cove Golf Course, in the amount of \$6,000.

BE IT RESOLVED, that the City Council hereby authorizes the Mayor to enter into an Independent Contractor Agreement with Metro Physical, Occupational, and Speech Therapy, PLLC to perform Physical and Occupational Therapy for members of the Senior Center from May 1st, 2023 - September 30th, 2023 for a total cost of \$70,000

BE IT RESOLVED, that the City Council hereby authorizes the Mayor to enter into a one-year contract with Stryker Corporation commencing July 8, 2023 and ending July 7, 2024, for preventative maintenance service of five (5) LifePak 15 cardiac monitors at a cost of \$9,918.00.
