A New Chapter in Leadership

At the first City Council meeting of the year, **Associate City Court Judge Ellen Savino** was also sworn in, marking a historic milestone as the City of Glen Cove's first female judge.

The Glen Cove Police Department has entered a new chapter of leadership. After **29 years** with the department, **Chief William Whitton retired**, and we thank him for his dedicated service to the City of Glen Cove.

Chief Christopher Ortiz was sworn in on **November 18**, beginning a new era for the department. A **Glen Cove resident** and the department's **first Hispanic Chief and one to hold a Ph.D.**, he brings a deep understanding of the community and a forward-looking focus on public safety and partnership. He is joined by **Deputy Chief Pietro "Peter" DiMaggio**, promoted on **December 9**.

Major Projects Shaping Glen Cove's Future



Glen Cove Golf Course – Sprinkler System Replacement

The full replacement and modernization of the golf course's irrigation system remains on schedule for completion in spring 2026. This new system will greatly improve playability, increase water efficiency, and enhance overall course conditions for residents and visitors.

Major Water Infrastructure Upgrades

In 2026, the City anticipates the complete replacement of the Nancy Court water well, along with the installation of a new air stripper (packed aeration tower) at the Duck Pond Road well site. These upgrades will strengthen the City's water treatment capabilities and support long-term water quality for residents.



Ferry Service Interest and Next Steps

A ferry operator has formally expressed interest in launching service in Glen Cove. Discussions are in progress, and the City expects to have a clearer understanding of feasibility and next steps during 2026.



Crescent Beach potential Summer 2026 Opening

Crescent Beach is showing encouraging progress after many years of closure. Measures addressing bacteria from the nearby stream are yielding positive results, and the City has been advised it may begin the 2026 beach-season application process, with required advisories. This is not yet formal approval to reopen, but we are hopeful.

New Noise Ordinance Hours

New noise ordinance hours. Friendly reminder: power equipment (mowers, blowers, saws, etc.) is now limited to 8 AM-7 PM weekdays & 9 AM-4 PM weekends. No commercial work on Sundays or holidays. Let's keep Glen Cove peaceful.

Recycling & Sanitation

Recycling and sanitation schedules, including yard waste guidelines, are available through the Department of Public Works. The garbage and recycling schedule, including holiday changes, can be downloaded on the City website at glencoveny.gov/public-works.

Snow & Ice Removal

Residents and commercial property owners are required to clear snow and ice from sidewalks within 12 hours of a snowfall. Slippery areas must be treated with concrete-safe ice melt or sand. Please clear a path at corner properties, keep access clear around trash cans, and do not push or place snow into city streets.

Snow Emergencies & Parking

When a Snow Emergency is declared:

- Park in driveways whenever possible
- If no driveway is available, park on the odd-numbered side of the street
- Overnight parking will be allowed in both municipal parking garages.
- No parking on Glen Street, School Street, or Bridge Street

Vehicles parked in violation of Snow Emergency rules may be ticketed or towed.
