Re: Ordinance No. 67 – Governing Weight Limits

The Town Board of the Town of Grand Rapids, Wood County, Wisconsin,
RESOLVES as follows:

The Town Board of the Town of Grand Rapids, Wood County, Wisconsin, has the specific authority under Chapters 60 and 66 of Wisconsin Statutes, and specifically § 60.22, Wis. Stats. to amend this ordinance.

Changes to Ordinance 67 – Governing Weight Limits

Amending section 67.2 Special Weight Limitations, to read as follows:

67.2 Special Weight Limitations

Pursuant to sec. 349.16(1) Wis. Stats., a gross weight limitation of 48,000 pounds per vehicle shall be in effect on the following town highways:

48th Street from Townline Road north to Washington Street
Washington Street from 80th Street west to 6011 Washington Street
64th Street from Townline Road north to South Park Road
64th Street from North Park Road to State Trunk 54
64th Street from State Trunk 54 to Biron village limits
Lake Ave from 42nd Street to 23rd Street
23rd Street from Lake Ave to Chestnut Street
32nd Street S. from Townline Road north to County Z
32nd Street S. from Two Mile Ave north to County W
49th Street S. from Wazeecha Ave north to County W
56th Street S. from Helke Road north to County W
45th Street S. from Wazeecha Ave north to County W
Whitrock Ave from 48th Street S. east to 80th Street S.
Grove Ave from 64th Street S. east to 80th Street S.
Deer Road from 64th Street S. east to 80th Street S.
