Wetland Restoration - Elk River Estates - Eric Peterson- The board discussed property site is 1107 59th Avenue SE, St. Cloud, MN 56304 parcel ID 25-412-0175. The Petersons are requesting to excavate a longer, narrower area so as not to impact the deeper portion of the wetland. The purpose of this project is to enhance wildlife habitat. The construction of the project will take place December, 2023 through December, 2024 pending regulatory approval. The Petersons have been working with Sherburne County on this and Supervisor Eric Meyer went to the site and discussed this expanding of the pond. He made the comment that he has no concerns for there is already an existing pond; they would just like to expand it. After discussion on this, Supervisor Mark Knowles made a motion to give positive comment and township approval to work in the drainage easement for the expansion of this pond and give Supervisor Eric Meyer the authority to e-mail and/or sign documents electronically if needed for Sherburne County to continue working with the Petersons on this request. BUSINESS FROM THE SUPERVISORS

Supervisor Eric Meyer discussed that the internet server from Cloudnet is being restored. However for now the township will continue to use Tech Check and Town Web for the township server and Cyber Security.

Supervisor Randy Linn – Supervisor Eric Meyer made the comment that Supervisor Randy Linn is out of town with his family. He did look into the Local Road Improvement Program (LRIP) Funding. It has all been filled out and applied for. The amount applied for was around \$700,000.00. It is included on the iPad. After discussion on this, Supervisor Joseph Sexton made a motion to accept, approve and sign the resolution that was presented in the iPads for the application of the LRIP funding request. Supervisor Joseph Then – Supervisor Joseph Then reported that some tree trimming has been completed. He will wait for estimates for the next trees before any more will be

trimmed. The Knoblach tree has been removed and he is waiting for the United States Postal Service to confirm to move the mailbox to the west side of the road. Some signs have been installed. There are some potholes in the roads but not sure if they can do anything with them yet due to the weather. He will look into if we need the yield sign or not in the Kilian neighborhood.

Supervisor Joseph Sexton – Supervisor Joseph Sexton talked about the fire bills. We are making headways. Supervisor Eric Meyer made the comment that he is working with the fire department to use the HeyGov website so we get the bills faster and the information is available to us quicker.
