

## **MINUTES OF THE REGULAR MONTHLY BOARD MEETING**

### **Haven Township – January 20, 2026**

#### **CALL TO ORDER**

The Haven Town Board met at the Haven Town Hall on Tuesday, January 20, 2026. The meeting was called to order at 7:00 p.m. by Chairperson Eric Meyer. Members present: Supervisor Eric Meyer, Supervisor Randy Linn, Supervisor Kari Watkins, Ben Oleson (Hometown Planning attended virtually), Treasurer Viki Monroe and Clerk Tammy Schefers. There were four people who attended virtually. There were seven people who attended in person.

#### **PLEDGE OF ALIGIANCE**

All present stood and recited the Pledge of Allegiance.

#### **SHERBURNE COUNTY SHERIFF REPORT**

Sergeant Aaron Sturm reported that there were 103 incidents for the month of December 2025. He reviewed and summarized the report with the board members and answered any questions.

#### **ELECTION OF OFFICERS**

Supervisor Randy Linn made a motion to appoint and keep Supervisor Eric Meyer as the Chairperson for the year 2026. Supervisor Kari Watkins seconded the motion. Role call was taken; Supervisor Randy Linn – Aye; Supervisor Eric Meyer – Aye; Supervisor Kari Watkins – Aye; the motion carried.

#### **OPEN FORUM (Time for Residents to Ask the Board Questions)**

Kathi Sims-Kosloski – She is the representative for Haven Township that attends the Planning & Zoning Meetings at Sherburne County. She spoke to the board members of some information from the County that will be coming to the townships for comment. The subjects that are coming up for discussion will be septic drain field systems, the changing in the soil depth of drain field (3 feet to 2 feet); Acreage for Agricultural Rural Areas (% Wooded, Wet Land, etc.) and Hamlets within Townships. She made the comment that if the board does not receive information on these items within a week or so, please reach back out to her and she will see that the board gets the information. She is also willing to speak and bring back the township's comments if the township does not want to submit comments in writing.

Gary Kiffmeyer asked the board if they could please send out a snow plow truck to salt and sand Haven Road. It is very icy and slippery.

## **BUILDING PERMITS**

Just for reference; Sherburne County sends an e-mail report of permits each month to the Clerk for all the Townships. There were 9 permits for Haven Township this month.

## **OLD BUSINESS**

**Hansen IUP – Legal Update** – Supervisor Eric Meyer stated that the board had sent out a letter update to all the residents in the Deer Haven area to update them on the current legal status of this case.

**Amrize** – The Environmental Impact Statement (EIS) is still in process. There are no further new updates.

**Haven Township Planning Commission Update** – Collin Gau spoke to the board members and gave them an informational update of the last meeting. The topics he talked about were; Considering Amendments to Haven Township Zoning Ordinance, Ordinance No.2025-07; Mineral Extraction Ordinance; Orderly Annexation Agreement; Cannabis Business Zoning Regulations; MN Pollution Control Agency Actions to the PFAS on County Road 8 and Re-Defining Haven Township Zoning Districts.

### **Ben Oleson (Hometown Planning) -**

**K & C Auto/Import Motors Auto** – Ben Oleson made the comment that he is still in the process of this Interim Use Permit Application from Import Motors LLC. He will reach out to the applicant and the applicant's legal counsel to keep this moving along.

**Wiilo Event Center** – Ben Oleson made the comment that he is waiting for them to comply with all the conditions. The Clerk made the comment that a representative from Wiilo Event Center stopped by the town hall today and asked what the status is of the Event Center IUP, the clerk gave him Ben Oleson's contact information.

**Mining Ordinance** – Ben Oleson made the comment that the final Mineral Extraction Ordinance has been posted. Haven Township will wait for a response from Amrize.

## **NEW BUSINESS**

**Minnesota Pollution Control Agency (MPCA)** – Supervisor Eric Meyer spoke to the board members about how this past year several testing wells were placed in Haven Township off of County Road 8 to monitor the water. The MPCA sent out letters to property owners to investigate further groundwater contamination in this area. Sampling of the wells around County Road 8 has revealed concentrations of per-and polyfluoroalkyl substances (PFAS) at concentrations exceeding the Minnesota Department of Health's (MDH) drinking water criteria. Another name that was used was "Forever Chemicals". Further studies and information will be available in the future. Supervisor Eric Meyer made the comment that he is trying to connect with the Minnesota Pollution Control Agency to see if they would be interested in attending a meeting with Haven Township to explain and answer questions.

## **BUSINESS FROM THE SUPERVISORS**

### **Supervisor (Chairperson) Eric Meyer**

Orderly Annexation with the City of St. Cloud – Supervisor Eric Meyer made the comment that the 1<sup>st</sup> draft of Redlines for the Orderly Annexation Agreement has been presented which still require further attorney review prior to execution by the township. Supervisor Eric Meyer made the comment that he would like to have another public open house for residents sometime in February 2026 to answer any questions. This will also be discussion at the March Annual Township Meeting.

Supervisor Eric Meyer talked with the board members about legal counsel. He made the comment that David Meyers from Rinke Noonan is going to retire in the near future. After discussion on this Supervisor Eric Meyer made a motion that Haven Township should still use Rinke Noonan when needed but switch the majority of its legal counsel to Couri & Ruppe, P.L.L.P. Supervisor Randy Linn seconded the motion. Role call was taken; Supervisor Randy Linn – Aye; Supervisor Eric Meyer – Aye; Supervisor Kari Watkins – Aye; the motion carried.

Supervisor Eric Meyer made the comment that he has been getting Spam e-mails so he wanted to give the rest of the board members a heads up to keep an eye out for this and be aware not to open any of them.

**Supervisor Randy Linn** – Supervisor Randy Linn handed out to the board members the revised draft copy of the Funds of Receipts and Disbursements for them to review. This will be discussed at the February Budget Meeting.

Supervisor Randy Linn discussed the Report of Outstanding Indebtedness with the board members. He discussed that the total bonds outstanding at the end of the year (December 31, 2025) is \$2,020,000.00. The Debt Service Funds are \$139,736.00. After discussion on this Supervisor Randy Linn made the motion to have the Treasurer accept, approve, sign and e-mail this back to the proper people who need it for the end of the year reporting. Supervisor Eric Meyer seconded the motion. Role call was taken; Supervisor Randy Linn – Aye; Supervisor Eric Meyer – Aye; Supervisor Kari Watkins – Aye; the motion carried.

Supervisor Randy Linn also discussed that the board needs to have a separate fund for this Debt Service. After discussion on this Supervisor Randy Linn made the motion to have the Treasurer make a separate fund for the Debt Service and transfer funds out of the Road Fund and place it into the new Debt Service Fund in the amount of \$139,736.00. Supervisor Eric Meyer seconded the motion. Role call was taken;

Supervisor Kari Watkins also made the comment that she has applied for and received a Haven Township domain for .gov. This will not be currently used yet, she has it ready incase it is needed in the future.

Supervisor Kari Watkins made the comment that she will be attending the Sherburne County Association of Townships (SCAT) meeting coming up this week.


#### **ADJOURN**
