ESTABLISHMENT OF AND APPOINTMENT OF MEMBERS TO THE HIGHLAND HAVEN PROPERTY DEVELOPMENT PLANNING COMMITTEE

WHEREAS the City does not now have in place a comprehensive development plan.

BE IT ALSO RESOLVED that the Committee shall strive to produce a plan for Planning and Zoning Board consideration not later than November 30, 2004 while operating under the following guidance:

- 1. Committee members shall elect Committee Chairman and other positions as desired.
- 2. Maximum citizen input shall be solicited.
- 3. The plan should reflect the appearance and nature of the City 5 10 years in the future by answering the following questions:
 - a. Feasibility/desirability of allowing commercial development other than that already authorized by current zoning. If so; where, what type, and restrictions.
 - b. Feasibility/desirability of allowing multi-family housing. If so; where, what type, and restrictions.

- c. Desired restrictions to impose on building in undeveloped areas (lot size, residence size, setbacks, streets etc) compared to those now in place for old HH Subdivision. Should the restrictions be the same, greater, or less and justification.
- d. Should PPD #1 stay as is or should it be dissolved and incorporated into other zoning.
- e. What course should be pursued in resolving overlapping ETJ's with the cities of Granite Shoals and Sunrise Beach.
- 4. Research assistance and legal advice (City Attorney) available through the Mayor.
- 5. Correspondence and coping services through the City Secretary.
