**Whereas**, Curtis Fry served on the initial Board of Aldermen after Highland Haven was incorporated as a city in 1995.

**Whereas**, Curtis Fry has served several terms on the Board of Directors of the Highland Haven Property Owners Association.

**Whereas**, Curtis Fry designed and supervised the construction of the Community Center and City Hall parking lots.

**Whereas**, Curtis Fry designed and supervised the construction of the Blackbird – Redbird – Highland Drive drainage system.

**Whereas**, Curtis Fry designed and supervised the construction of the Highland Drive drainage system.

**Whereas**, Curtis Fry was a significant contributor to the construction of one of the first Highland Haven drain systems on East Heron Drive.

Whereas, Curtis Fry designed the just completed Dry Creek Crossing.

**Whereas**, Curtis Fry was instrumental in the preparation of the FEMA grant request that funded the new Dry Creek crossing.

**Whereas**, Curtis Fry designed and supervised the construction of the Eagle Road – Crane Drain project.

**Whereas**, Curtis Fry lead the extensive and exhaustive elevation survey of the entire city that is the basis for the FEMA drain project design.

**Whereas**, Curtis Fry's volunteer survey team has contributed \$44,500 in-kind funding for the FEMA drain project.

Whereas, Curtis Fry was instrumental in the preparation of the successful FEMA Drain Project grant request.

Whereas, Curtis Fry surveyed the city parks supporting the placement of park corner markers.
