Resolution authorizing the City of Highland Haven to participate in TexPool and designation authorized representative from the City.

Whereas, the City of Highland Haven ("Participant") is a local government of the State of Texas and is empowered to delegate a public funds investment pool the authority to invest funds and to act as custodian of investments purchased with local investment funds; and

Whereas, it is in the best interest of the Participant to invest local funds in investments that provide for the preservation and safety of principal, liquidity, and yield consistent with the Public Funds Investment Act; and

Whereas, the Texas Local Government Pool ("TexPool"), a public funds investment pool, was created on behalf of entities whose investment objectives in order of priority are preservation and safety of principal, liquidity, and yield consistent with the Public Funds Investment Act.

Now therefore, be it resolved as follows:

- A. That Participant shall enter into a Participation Agreement to establish an account in its name in TexPool.
- B. That the individuals, whose signatures appear in this Resolution, are authorized representatives of the participant and are each hereby authorized to transmit funds for investment in TexPool and are each further authorized to withdraw funds from time to time, to issue letters of instruction, and to take all other actions deemed necessary or appropriate for the investment of local funds.
