ORDINANCE NO. 109

AN ORDINANCE OF THE CITY OF HIGHLAND HAVEN, TEXAS CANVASSING THE SPECIAL ELECTION HELD JOINTLY WITH OTHER ENTITIES ON NOVEMBER 3, 2020 FOR THE PURPOSE OF ORDERING A SPECIAL ELECTION ON THE ADOPTION OF A LOCAL SALES AND USE TAX IN THE CITY OF HIGHLAND HAVEN, TEXAS AT THE RATE OF TWO PERCENT

WHEREAS, the Board of Aldermen of the City of Highland Haven, Texas, (known as the "City", located in Burnet County, Texas, after publication, did hold a public meeting on June 16, 2020, for purpose of calling for a Special Election to adopt a local Sales and Use Tax at the rate of two percent;

WHEREAS, the City, duly called for said election to be held on November 3, 2020, adopting the local Sales and Use Tax at the rate of two percent (2%);

WHEREAS, the City has made a provision to contract with the County Clerk of Burnet County (the "Burnet County Election Officer") to conduct the City's election, pursuant to Tex. Elec. Code, Chapters 31 and 271, Tex. Gov't Code Chapter 791, (the "Election Contract"), and to conduct a joint election with those political subdivisions that will hold an election on the same day in all or part of the same territory as the City, as authorized in Chapter 271, Tex. Elec. Code;

WHEREAS, the City hereby canvasses the returns of said election as which there was a submittal of notification to all residents and qualified voters of the city for their action on this;

WHEREAS, the City has diligently inquired into the poll list and official election returns which were duly and lawfully made available to the City holding such election and the official election returns showing the cast votes in this election.

NOW THEREFORE, BE IT ORDAINED BY THE BOARD OF ALDERMEN OF THE CITY OF HIGHLAND HAVEN, TEXAS THAT:

SECTION 1. Election; Returns; Canvass. The City officially finds, determines and declares that the Election was duly and properly conducted, that proper legal notice of such election was given in English and Spanish language, that proper election officers were duly appointed prior to the Election; that the Election was duly and legally held, that all residents, qualified voters of the City were permitted to vote at the Election, that due returns of the results of the Election have been made and delivered, and that the City has duly canvassed such returns, all in accordance with the laws of the State of Texas and that of the United States of America, and of the order calling the Election.
