**AN ORDINANCE OF THE TOWNSHIP OF JACKSON, CAMBRIA COUNTY,  
PENNSYLVANIA, PROVIDING FOR ENTERING INTO AN INTERGOVERNMENTAL  
COOPERATION AGREEMENT WITH CAMBRIA TOWNSHIP LOCATED WITHIN  
CAMBRIA COUNTY, PENNSYLVANIA, FOR THE PURPOSE OF ACQUIRING A  
PAVING MACHINE FOR THOSE PARTICIPATING MUNICIPALITIES.**

**WHEREAS**, the Township of Jackson and the Township of Cambria, located within Cambria County, Pennsylvania, desire to enter into a Intergovernmental Cooperation Agreement to provide for the joint purchase of a paving machine; and

**WHEREAS**, said municipalities, for the purpose of carrying the provisions of the Intergovernmental Cooperation Act into effect, deem it appropriate to enter into such Agreement;

**NOW THEREFORE**, be it Ordained and Enacted by the Supervisors of the Township of Jackson Township, Cambria County, Pennsylvania, and it is hereby Ordained and Enacted by the authority of and pursuant to the provisions of the Act of December 19, 1999, P.L. 1158, No. 177.53 Pa. C.S.A., Section 2301, et. Seq., also known as the Intergovernmental Cooperation Act (Act 77), as follows:

**SECTION 1**

1. The Township of Jackson hereby resolves to enter into an Intergovernmental Cooperation Agreement with the Township of Cambria for the purpose of jointly purchasing a Paving Machine.
2. The Township of Jackson hereby approves entering into the Agreement, a copy of which is attached hereto and incorporated herein by reference (and which shall be filed with the minutes of the meeting at which this Ordinance was enacted), with the intent and effect that the Township of Jackson shall be bound by the Agreement.
3. The Chairman of the Board of Supervisors and the Secretary are hereby authorized and directed on behalf of the Township of Jackson, (a.) to execute and deliver the Agreement, and (b.) to execute and deliver such additional instruments, and to take such further actions, as may be necessary or appropriate to carry forth the Agreement and the transactions to be effected under the Agreement, including payment of such amounts as are by the Township of Jackson pursuant to the Agreement.

## **SECTION 2**

If any sentence, clause, section, or part of this ordinance is for any reason found to be unconstitutional, illegal or invalid, such unconstitutional, illegality or invalidity shall not affect or impair any of the remaining provisions, sections, clauses, sections or parts of this ordinance. It is hereby declared as the intent of the Supervisors of the Township of Jackson that this ordinance would have been adopted had such unconstitutional, illegal or invalid sentence, clause, section or part therefore not been included herein.
