**RESOLUTION NO. 01-22**

**A RESOLUTION**

**OF THE BOARD OF SUPERVISORS OF THE TOWNSHIP OF JACKSON AUTHORIZING AND APPROVING AN AGREEMENT WITH THE JACKSON TOWNSHIP WATER AUTHORITY PROVIDING FOR INTERIM AND PERMANENT FUNDING FOR THE JACKSON TOWNSHIP WATER AUTHORITY TO CONSTRUCT THE WATER LINE PROJECT TO SERVICE THE TOWNSHIP'S BUSINESS PARK TO BE LOCATED IN JACKSON TOWNSHIP, CAMBRIA COUNTY PENNSYLVANIA, AS SET FORTH IN THE ATTACHED EXHIBIT, AND DIRECTING OTHER NECESSARY AND PROPER ACTION.**

BE IT RESOLVED, by the Board of Supervisors of the Township of Jackson (hereinafter the "Township"), as follows:

SECTION 1. This Township hereby approves an Agreement with the Township of Jackson, providing for interim and permanent funding for the Jackson Township Water Authority to construct the water line project to service the Township's business park to be located in Jackson Township, as set forth in Exhibit "A." (A copy of the Agreement, is attached hereto, incorporated herein by reference, and marked as Exhibit "A.")

SECTION 2. The Township hereby authorizes its officers to sign and/or execute any and all documents, agreements, contracts, and/or undertake any and all actions required to be delivered and/or taken by the Jackson Township Water Authority which are necessary to approve, implement, authorize, and/or complete and satisfy all terms and conditions of the Agreement set forth in Exhibit "A". The Chairman or Vice Chairman and the Secretary or Assistant Secretary of this Township, as applicable, are authorized and directed to execute, to attest, to acknowledge and to deliver the documents, on behalf of this Township, in the form so approved.

SECTION 3. Proper officers of this Township are authorized and directed to execute all documents and to do all other acts that may be necessary and proper to carry out this Resolution and the undertakings of this Township.

SECTION 4. It is declared that the adoption of this Resolution and the execution, acknowledgment and delivery of the documents are necessary for the protection, benefit and preservation of the health, safety and welfare of inhabitants of the Municipality and customers of the water service area.

SECTION 5. In the event any provision, section, sentence, clause or part of this Resolution shall be held to be invalid, such invalidity shall not affect or impair any remaining provision, section, sentence, clause or part of this Resolution, it being the intent of this Township that such remainder of this Resolution shall be and shall remain in full force and effect.

SECTION 6. This Resolution shall become effective immediately in accordance with law.

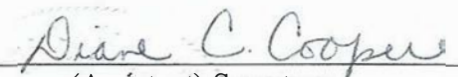
SECTION 7. All other resolutions or parts of resolutions inconsistent herewith expressly are repealed.
