## RESOLUTION 11-94

A RESOLUTION OF THE TOWNSHIP OF JACKSON,

CAMBRIA COUNTY, PENNSYLVANIA

AUTHORIZING THAT THE CHAIRMAN OF THE BOARD OF TOWNSHIP
SUPERVISORS TO ENTER INTO A HOLDING TANK AGREEMENT

The Board of Supervisors for Jackson Township recognize that development is important to the Township. Also, the Board of Supervisors are aware that sewage may be a health hazard to the Township and its residents. To further the development of the Township and health of its residents, the Board of Supervisors adopt the following Resolution:

WHEREAS, Edward and Rita Irvin (hereinafter referred to as "Irvins") are the owners of real estate located in Jackson on which an improvement is situate;

WHEREAS, the improvement that Irvins made to their real estate requires the installation of a sewage system or a recognized alternative;

WHEREAS, Irvins placed a holding tank on the real estate as an alternative to the sewage system for the improvement;

WHEREAS, Irvin will give Jackson the assurance that the holding tank will be pumped out on an as needed basis or that Jackson may pump the holding tank if either the contents in the tank become a health hazard or Irvin fails to pump out the holding tank;

WHEREAS, to assure that Jackson will not incur any expenses in pumping out the holding tank for any reason whatsoever, Irvin agrees to deposit \$2,500.00 with Portage National Bank to cover any cost that Jackson may incur in pumping out the holding tank;

WHEREAS, Portage agrees to notify Jackson in writing every 3 months that Irvin maintains \$ 2,500.00 in escrow as assurance that Jackson will not incur any expense;

WHEREAS, a Holding Tank Agreement must by executed by Irvins, Portage National Bank, and Jackson Township; and

WHEREAS, the Board of Supervisors for Jackson Township authorize its Chairman, David Somogyi, to execute the Holding Tank Agreement on behalf of the Township;

NOW THEREFORE, the Board of Supervisors for Jackson Township hereby adopt the following Resolution:

RESOLVED, that to further the development of the Township and health of its residents the Board of Supervisors shall enter into a Holding Tank Agreement with Edward and Rita Irvin and Portage National Bank;

RESOLVED FURTHER, that the Board of Supervisors hereby authorize the Chairman of the Board, David Somogyi, to execute the Holding Tank Agreement attached as Exhibit "A" on behalf of the Township;

NOW THEREFORE, this 15 day of December , 1994, the Board of Supervisors for Jackson Township hereby adopt the foregoing Resolution authorizing the Chairman of the Board of Supervisors, David Somogyi, to execute the Holding Tank Agreement.
