

**RESOLUTION OF THE BOARD OF TOWNSHIP SUPERVISORS OF JACKSON
TOWNSHIP, CAMBRIA COUNTY, PA APPROVING AND AUTHORIZING THE
SUBMITTAL OF AN APPLICATION FOR FY 2023 FUNDS UNDER
THE PA COMMUNITY DEVELOPMENT BLOCK GRANT PROGRAM**

WHEREAS, there is a need in Jackson Township for a program of housing and community development to address the needs of low- and moderate-income households; and

WHEREAS, funds are provided under the Housing and Community Development Act of 1974, as amended, to address the aforesaid housing and community development needs; and

WHEREAS, the Commonwealth of Pennsylvania has elected to accept a Block Grant from the U.S. Department of Housing and Urban Development and has developed a state Community Development Block Grant (CDBG) Program to address the housing and community development needs in the Commonwealth; and

WHEREAS, Jackson Township desires to address its housing and community development needs, and is requesting funds which have been allocated to the Township for FY 2023 under the Pennsylvania Act 179 of 1984; and

WHEREAS, the County of Cambria has agreed to administer the CDBG on behalf of the entitlement townships in the County; and

WHEREAS, the Redevelopment Authority of Cambria County, acting as the administrator of the CDBG Program for Cambria County, has prepared an application for funds under the FY 2023 CDBG Program Year and has held numerous public hearings throughout Cambria County.

NOW, THEREFORE BE IT RESOLVED, by the Board of Supervisors of Jackson Township and with the authority of the same as follows:

SECTION 1: The recitals set forth above are incorporated by reference thereto.

SECTION 2: The Fiscal Year 2023 State Community Development Block Grant Application for Jackson Township is hereby approved in all respects.

SECTION 3: The Three-Year Plan is approved.

SECTION 4: The Township is cognizant of the conditions that are imposed in the undertaking and carrying out of community development activities with Federal/State financial assistance under Title I, of the Housing and Community Development Act of 1974, including those under Title VI of the Civil Rights Act of 1964, as amended, relating

to the prohibition of discrimination because of race, color, creed, or national origin and other assurances as may be forthcoming from the State for the implementation of the program.

SECTION 5: The Township authorizes the Redevelopment Authority of Cambria County to file the said FY 2023 CDBG Application on behalf of Jackson Township in the amount of \$97,177.00.

BE IT FURTHER RESOLVED, if CDBG funds are determined by the Pennsylvania Department of Community and Economic Development to be expended on ineligible program costs or do not meet a national objective, Jackson Township agrees to repay the proportion deemed ineligible from non-federal sources.

BE IT DULY RESOLVED by the Board of Supervisors of Jackson Township at its regularly convened meeting held on October 12, 2023.
