TOWN OF LAFAYETTE CHIPPEWA COUNTY STATE OF WISCONSIN FIRST AMENDMENT TO ORDINANCE 85701

FIRST AMENDMENT TO ORDINANCE CREATING AND REGULATING THE BRICK MEMORIAL LANDING

WHEREAS, the Town enacted Ordinance 85701 (the "Ordinance") on August 6, 1985.

NOW, THEREFORE, as an amendment to the Ordinance, the Town Board enacts this First Amendment to the Ordinance (the "First Amendment"), as follows:

1. Section III of the Ordinance is deleted in its entirety and restated as follows:

Section III. REGULATIONS FOR USE OF BRICK MEMORIAL LANDING.

- A. Limited Parking. There shall be no overnight parking in the Brick Memorial Landing parking lot.
- B. <u>Hours.</u> The Town Board of the Town of Lafayette shall have the authority to regulate the daily hours during which the Brick Memorial Landing shall be open to the public.
- C. <u>Season</u>. The Town Board of the Town of Lafayette shall have the authority to regulate the dates on which the Brick Memorial Landing shall be open to the public, and shall have the right to open and close said landing as the weather conditions and public needs dictate.
- D. <u>Prohibited Conduct.</u> In addition to such other activities and conduct which the Town Board may, at its discretion, from time to time, deem necessary to limit or prohibit for the protection of the health and safety of the general public, or to maintain order at the Brick Memorial Landing, the following conduct shall be prohibited at all times:
 - 1. Loud and unnecessary noise.
 - 2. Picnicing.
 - 3. Swimming.
 - 4. Water skiing from the boat ramps.
 - 5. Loitering.
- 2. Section IV of the Ordinance is deleted in its entirety and restated as follows:

Section IV. FEE.

- A. <u>Fee Limitations.</u> The Town Board of the Town of Lafayette may establish a fee for the use of the Brick Memorial Landing, said fee not to exceed the amount of \$5.00 per day.
- B. <u>Collection of Fees.</u> The fee for use of the boat landing shall be collected and paid at the entry gate, prior to allowing the entry of a motor vehicle into the landing parking lot.

- C. <u>Issuance of Residential Permit Stickers.</u> Residents of the Town of Lafayette may apply at the Town of Lafayette Town Hall for a sticker allowing them the use of the Brick Memorial Boat Landing for the year in which the sticker is issued. A \$5.00 administrative costs fee shall be charged for each permit sticker so issued.
- 3. Section V of the Ordinance is deleted in its entirety and restated as follows:

Section V. ENFORCEMENT.

- A. The Town Board Members of the Town of Lafayette are hereby authorized to enforce the rules and regulations set forth herein and may do so by all legal means, including but not limited to the following:
 - 1. Erection of an entry gate.
 - 2. Posting of a minimum of two (2) signs on the landing site setting forth the above rules and regulations and such other rules and regulations as the Town Board may, from time to time, deem necessary for the health and safety of the general public.
 - 3. Issuance of municipal citations for violation of the terms of this Ordinance.
- B. In the pursuance of such authority, the Town Board may, from time to time, hire such assistants as may be necessary to carry out the terms of this Ordinance.
- 4. Section VI of the Ordinance is deleted in its entirety and restated as follows:

Section VI. PENALTIES.

Any person who violates this Ordinance shall not more than \$50.00. For any person who violates the provisions of this Ordinance more than one (1) time, said person shall forfeit not less than \$100.00. Any person who interferes with or removes any sign, gate, pier, or other infrastructure installed by the Town for use of the boat landing shall forfeit not more than \$500.00. Said forfeitures shall include the cost of prosecution plus all court costs, including reasonable attorney's fees under Wisconsin law.

5. Except as amended by this First Amendment, all other terms and conditions of the Ordinance shall remain unchanged and in full force and effect. All capitalized terms used in this First Amendment which are not otherwise defined herein shall have the meanings ascribed to such terms in the Ordinance.

AMENDMENT TO THE TOWN OF LAFAYETTE BRICK MEMORIAL LANDING

ORDINANCE NO. 85701, July 1985

The Town Board of the Town of LaFayette, Chippewa County, Wisconsin, does hereby ordain as follows:

- 1. That SECTION IV FEE as follows:
- A. Fee Limitations. The Town Board may establish a fee for the use of the Brick Memorial Landing, said fee not to exceed the amount of \$ 5.00 per day.

B. Collection of Fees. The fee for use of the boat landing shall be collected and paid at the entrance, prior to allowing the parking of a motor vehicle into the landing parking lot.

- C. Issuance of Residential Permit Stickers. Residents of the Town of Lafayette may apply at the Lafayette Town Hall for a sticker allowing them the use of the Brick Memorial Boat Landing for the year in which the sticker is issued. A \$ 5.00 administrative costs fee shall be charged for each permit sticker so issued.
- D. Non-Residents may apply at the Lafayette Town Hall for a sticker allowing them the use of the Brick Memorial Boat Landing for the year in which the sticker is issued. A \$ 50.00 administrative costs fee shall be charge for each permit sticker so issued.

The second subjection of provided by law
This ordinance shall take effect upon passage and publication as provided by law.
