

AN ORDINANCE CREATING AND REGULATING THE BRICK MEMORIAL LANDING IN THE TOWN OF LAFAYETTE

ORDINANCE NO. 85701

July 1985

ORIGINAL The Town Board of the Town of Lafayette, Chippewa County, Wisconsin, does ordain as follows:

SECTION I - STATEMENT OF INTENT

The town boat landing, hereby created is owned and maintained by the Town of Lafayette, for the benefit of the general public and the Town, in the proper exercise of its police powers, has the right and duty to manage and control Town owned property for the good order of the Town and for the health, safety, welfare and convenience of the public.

SECTION II - CREATION OF THE BRICK MEMORIAL LANDING

The Town Board of the Town of Lafayette, hereby creates the Brick Memorial Landing, located in the Town of Lafayette on the land described as follows:

Lot D of Sun Rise Point Addition to the Town of Lafayette, except the parcel sold to the State of Wisconsin as a part of Highway "29" which is now County Highway X.

for the purpose of embarkation and disembarkation of boats on Lake Wissota.

SECTION III. REGULATIONS FOR USE OF BRICK MEMORIAL LANDING.

- A. Capacity and Right to Entry. The capacity of the parking lot for the Brick Memorial Landing shall be set at Fifty (50) cars or trucks, with boat trailers and entry shall be on a first come-first serve basis.
- B. Limited Parking. There shall be no overnight parking in the Brick Memorial Landing parking lot.
- C. Hours. The Town Board of the Town of Lafayette shall have the authority to regulate the daily hours during which the Brick Memorial Landing shall be open to the public.
- D. <u>Season</u>. The Town Board of the Town of Lafayette shall have the authority to regulate the dates on which the Brick Memorial Landing shall be open to the public, and shall have the right to open and close said landing as the weather conditions and public needs dictate.
- E. <u>Prohibited Conduct</u>. In addition to such other activities and conduct which the Town Board may, at its discretion, from time to time, deem necessary to limit or prohibit for the protection of the health and safety of the general public, or to main-

tain order at the Brick Memorial Landing, the following conduct shall be prohibited at all times:

- 1. Loud and unnecessary noise.
- 2. Picnicing.
- 3. Swimming.
- 4. Water skiing from the boat ramps.
- 5. Loitering.

SECTION IV - FEE

- A. <u>Fee Limitations.</u> The Town Board of the Town of Lafayette may establish a fee for the use of the Brick Memorial Landing, said fee not to exceed the amount of \$3.50 per day.
- B. <u>Collection of Fees.</u> The fee for use of the boat landing shall be collected and paid at the entry gate, prior to allowing the entry of a motor vehicle into the landing parking lot.
- C. <u>Issuance of Residential Permit Stickers</u>. Residents of the Town of Lafayette may apply at the Town of Lafayette Town Hall for a sticker allowing them the use of the Brick Memorial Boat Landing for the year in which the sticker is issued. A \$1.00 administrative costs fee shall be charged for each permit sticker so issued.

SECTION V - ENFORCEMENT

- A. The Town Constable and the Town Board Members of the Town of Lafayette, are hereby authorized to enforce the rules and regulations set forth herein and may do so by all legal means, including but not limited to the following:
 - 1. Erection of an entry gate.
 - 2. Posting of a minimum of two (2) signs on the landing site setting forth the above rules and regulations and such other rules and regulations as the Town Board may, from time to time, deem necessary for the health and safety of the general public.
 - 3. Issuance of municipal citations for violation of the terms of this ordinance.
- B. In the pursuance of such authority, the Town Constable and the Town Board may, from time to time, hire such assistants as may be necessary to carry out the terms of this ordinance.

SECTION VI - PENALTIES

Any person who violates any of the provisions of this ordinance may be required to forfeit not less than \$5.00 nor more than \$25.00 for a first offense and not less than \$15.00 nor more than \$50.00 and/or imprisonment for not more than thirty (30) days for the second or subsequent offense within any twelve (12) month period.

SECTION VII - LIABILITY FOR DAMAGES

This ordinance shall not be construed as an assumption of liability by the Town of Lafayette because of injury sustained or property damaged or destroyed while on the subject premises.

SECTION VIII - SEVERABILITY

If any section, subsection, sentence, clause or phrase of this ordinance is, for any reason, held to be invalid, such decision shall not affect the validity of the remaining portions of this ordinance. The Town Board hereby declares that it would have passed this Ordinance and each section, subsection, sentence, clause and phrase thereof, irrespective of the fact that any one or more sections, subsections, sentences, clauses and phrases, be declared unconstitutional.

SECTION IX - EFFECTIVE DATE

This ordinance shall take effect upon passage and publication as provided by law.

The foregoing Ordinance was adopted at a regular meeting of the Town Board of the Town of Lafayette on the 65 day of august, 1985.
