**RESOLUTION TO ESTABLISH WARD BOUNDARIES TO REFLECT POPULATION CHANGES  
ACCORDING TO THE 2020 CENSUS OF POPULATION**

**WHEREAS**, following the 2020 Census of Population municipalities are required to adjust the boundaries for those wards which have either gained or lost population and as a result no longer fit with the statutory population ranges; and

**WHEREAS**, municipalities are required to make a good faith effort to accommodate the tentative plan submitted by the county.

**NOW, THEREFORE, BE IT RESOLVED**, that the Town of Lafayette, Chippewa County, Wisconsin does hereby recognize the population of wards as follows for the purposes of setting up voting districts:

**Ward 1**

Town of Lafayette east of the following line: 210<sup>th</sup> St north from the County line, then west on 40<sup>th</sup> Ave, then north on County Hwy K, then west on County Hwy X, then north on County Hwy K to the north town line.

Polling Place: Lafayette Town Hall, 5765 197<sup>th</sup> St, Chippewa Falls, WI 54729

**Ward 2**

Town of Lafayette lying within a line going south on County Hwy K at the north town line, then west along 70<sup>th</sup> Ave, then south along 190<sup>th</sup> St, then northwesterly along 189<sup>th</sup> St, then west along 70<sup>th</sup> Ave, then north along 178<sup>th</sup> St, then east on the extension of 178<sup>th</sup> to the shore of Lake Wissota, then north along shore of Lake Wissota to a point, then northwesterly to the north town line, then east along the north town line to County Hwy K.

**Ward 3**

Town of Lafayette lying within a line beginning at the intersection of the Wisconsin Central Railroad and County Hwy K, then north along County Hwy K, then west along 70<sup>th</sup> Ave, then south along 190<sup>th</sup> St, then northwesterly along 189<sup>th</sup> St, then west along 70<sup>th</sup> Ave, then north along 178<sup>th</sup> St, then east on the extension of 178<sup>th</sup> to the shore of Lake Wissota, then north along shore of Lake Wissota to a point, then northwesterly to the north town line, then south along the west town line to the Lake Wissota dam, then south to the south shore of the Chippewa River, then southeasterly to the railroad bridge, then east along the railroad to County Hwy K.

**Ward 4**

Town of Lafayette lying within a line beginning at the intersection of County Hwy X and County Hwy K, then north along County Hwy K, then west along the railroad, then south on 190<sup>th</sup> St, then east on County Hwy X, then south on 192<sup>nd</sup> St, then east on 55<sup>th</sup> Ave, then south on 197<sup>th</sup> St, then continuing south on 195<sup>th</sup> St, then west on 50<sup>th</sup> Ave, then south on 180<sup>th</sup> St, then west on State Hwy 29 to Stillson Creek, then south to the south line State Hwy 29, then east along State Hwy 29, then north along County Hwy K to the intersection of County Hwy X.

Population: 671

Polling Place: Lafayette Town Hall, 5765 197<sup>th</sup> St, Chippewa Falls, WI 54729

**Ward 5**

Town of Lafayette lying south and east of a line described as 50<sup>th</sup> Ave east from the west town line, east along State Hwy 29, then south along County Hwy K, then east on 40<sup>th</sup> Ave, then south on 210<sup>th</sup> St to the south town line.

Polling Place: Lafayette Town Hall, 5765 197<sup>th</sup> St, Chippewa Falls, WI 54729

**Ward 6**

Town of Lafayette lying within a line beginning at the intersection 50<sup>th</sup> Ave and 195<sup>th</sup> St, north on 195<sup>th</sup> St, then continuing north on 197<sup>th</sup> St, then west on 55<sup>th</sup> Ave, then north on 192<sup>nd</sup> St, then west on County Hwy X, then north on 190<sup>th</sup> St, then west along the railroad to the railroad bridge, then south along the thread of Stillson Creek to State Hwy 29, then east along State Hwy 29, then north along 190<sup>th</sup> St, then east along 50<sup>th</sup> Ave to the intersection of 195<sup>th</sup> St.

Polling Place: Lafayette Town Hall, 5765 197<sup>th</sup> St, Chippewa Falls, WI 54729

**Ward 7**

Town of Lafayette lying within a line where 50<sup>th</sup> Ave goes east from the west town line, then east along State Hwy 29, then north along the thread of Stillson Creek to County Hwy X, then west along County Hwy X, then west along State Hwy 29, then south along the west town line to 50<sup>th</sup> Ave

Population: 743

Polling Place: Lafayette Town Hall, 5765 197<sup>th</sup> St, Chippewa Falls, WI 54729

**Ward 8**

Town of Lafayette lying within a line beginning at State Hwy 29 going east from the west town line, then continuing east along County Hwy X to the bridge, then northwest to west shore of Lake Wissota at Eagle Point town line, then west along river to the boundary of the City of Chippewa Falls, then south along the eastern boundary of the City of Chippewa Falls to State Hwy 29, also all portions of the Town of Lafayette lying west of the east boundary of the City of Chippewa Falls.

Polling Place: Lafayette Town Hall, 5765 197<sup>th</sup> St, Chippewa Falls, WI 54729

**BE IT FURTHER RESOLVED,**

Ward 1 created above shall be represented by Supervisory District No. 11 and  
Wards 2-5 created above shall be represented by Supervisory District No. 12 and  
Wards 6-8 created above shall be represented by Supervisory District No. 20 and

**BE IF FURTHER RESOLVED** that the Town of Lafayette, does hereby adopt the ward plan according to the attached map and listing of census blocks.

**BE IT FURTHER RESOLVED** that the municipal clerk is required to forward a copy of the ward plan to the Chippewa County Clerk within five (5) days after the municipality has enacted or adopted an ordinance or resolution creating wards in accordance with the tentative county supervisory redistricting plan.

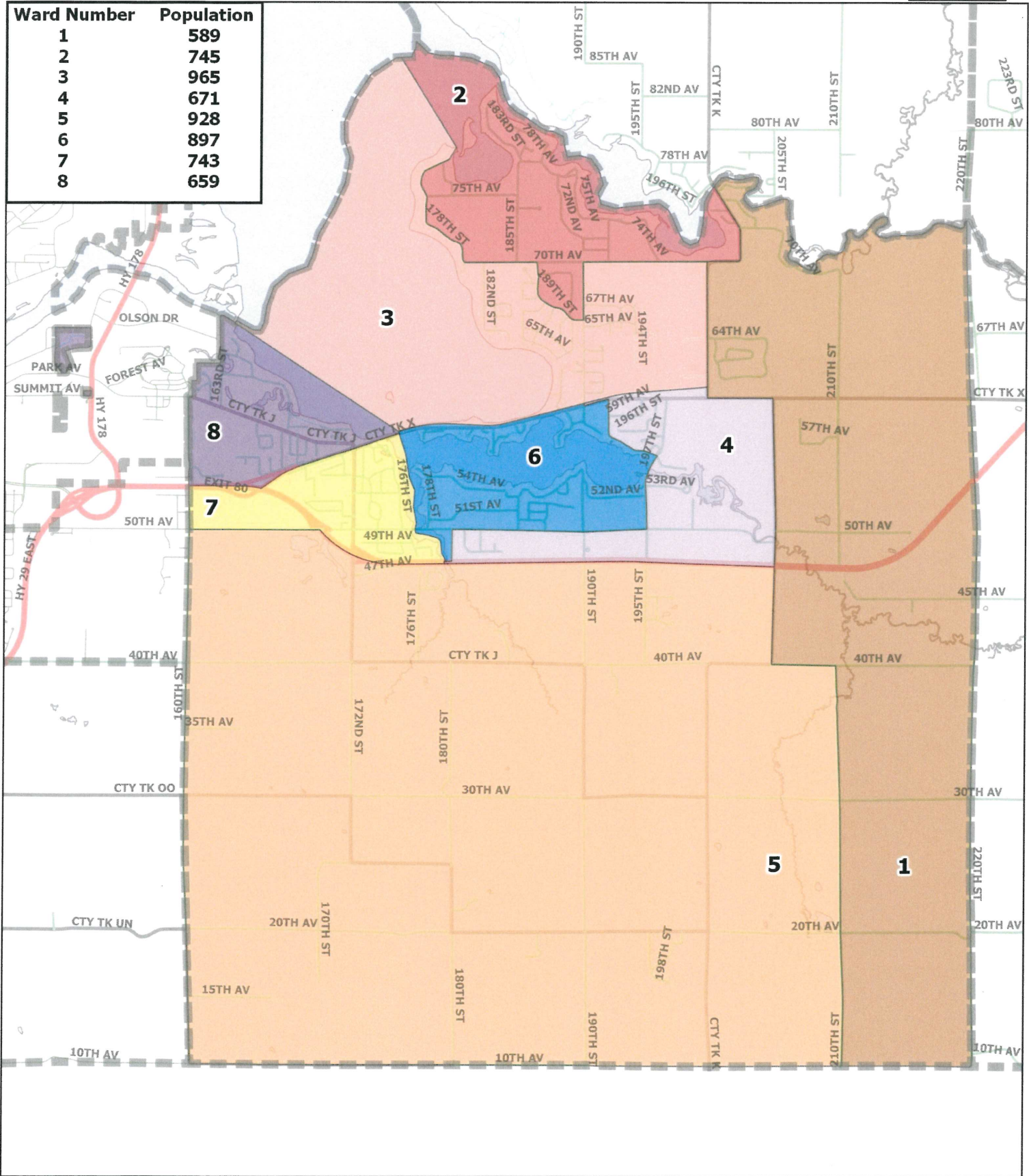
