FOURTH AMENDMENT TO ORDINANCE 2017-1 DESIGNATING ALL-TERRAIN VEHICLE AND UTILITY-TERRAIN VEHICLE ROUTES AND REGULATING THE OPERATION OF ALL TERRAIN VEHICLES AND UTILITY TERRAIN VEHICLES IN THE TOWN OF LAFAYETTE, CHIPPEWA COUNTY, WISCONSIN

WHEREAS, the Town enacted Ordinance 2017-01 (the "Ordinance") on December 18, 2017, and amended on March 19, 2019, and August 19, 2019, to designate ATV routes and regulate operation of ATVs and UTVs in the Town of Lafayette.

NOW, THEREFORE, as an amendment to the Ordinance, the Town Board enacts this Fourth Amendment to the Ordinance (the "Fourth Amendment"), as follows:

- 1. Section F, Conditions of Use, To operate an all-terrain vehicle a person must: Line 8, page 4 of the Ordinance is amended to revise the operation hours as follows: Operate no earlier than one-half hour before sunrise and 11:00 pm consistently all year.
- 2. Except as amended by this Fourth Amendment, all other terms and conditions of the Ordinance shall remain unchanged and in full force and effect. All capitalized terms used in this Third Amendment which are not otherwise defined herein shall have the meanings ascribed to such terms in the Ordinance.
