FFIFH AMENDMENT TO ORDINANCE 2017-1 DESIGNATING ALL-TERRAIN VEHICLE AND UTILITY-TERRAIN VEHICLE ROUTES AND REGULATING THE OPERATION OF ALL TERRAIN VEHICLES AND UTILITY TERRAIN VEHICLES IN THE TOWN OF LAFAYETTE, CHIPPEWA COUNTY, WISCONSIN

WHEREAS, the Town enacted Ordinance 2017-01 (the "Ordinance") on December 18, 2017, and amended on March 19, 2019, and August 19, 2019, to designate ATV routes and regulate operation of ATVs and UTVs in the Town of Lafayette.

NOW, THEREFORE, as an amendment to the Ordinance, the Town Board enacts this Fifth Amendment to the Ordinance (the "Fifth Amendment"), as follows:

- 175th Street from 54th Avenue Intersection to 53rd Avenue Intersection

- 49th Avenue from Intersection of 174th Street to 49th Avenue Dead End
- 49the Avenue from Intersection of 174th Street to 177th Street Intersection
- 48th Avenue from Intersection of 174th Street to 176th Street
- 176th Street from Intersection of 49th Avenue to 48th Avenue
- 177th Street from South Dead End to Behind Sand Bar
- 177th Street from Intersection of 177th Street to 177th Street Dead End
- New Roads for Ordinance Southeast of 50th Avenue
- 50th Avenue from Intersection of County Road J to 160th Street Intersection
- 160th Street from Intersection of 50th Avenue to 20th Avenue Intersection
- 40th Avenue from Intersection of 160th Street to County Road J Intersection
- 35th Avenue from Intersection of 160th Street to 35th Avenue Dead End
- 172nd Street from Intersection of 40th Avenue to 30th Avenue Intersection
- 30th Avenue from Intersection of 172nd Street to County Road J Intersection
- 180th Street from Intersection of County Road J to County Road OO Intersection
- 190th Street from Intersection of County Road J to 10th Avenue Intersection
- 10th Avenue from Intersection of 190th Street to 180th Street Intersection
- 180th Street from Intersection of 10th Avenue to 20th Avenue Intersection
- 20th Avenue from Intersection of County Road OO to 160th Street Intersection
- 170th Street from Intersection County Road OO to 170th Street Dead End
- 2. Except as amended by this Fifth Amendment, all other terms and conditions of the Ordinance shall remain unchanged and in full force and effect. All capitalized terms used in this Third Amendment which are not otherwise defined herein shall have the meanings ascribed to such terms in the Ordinance.
