Licenses are not transferable or refundable. It is the resident's responsibility to license their dog. There is a \$ 5.00 late fee after March 31st of each year.

KENNEL LICENSE INFORMATION PER DOG LICENSE & DOMESTIC ANIMAL REGULATION

ORDINANCE 87-9-TS / (3) **KENNEL LICENSE**. (a) **General**. Licenses kennels shall be permitted subject to zoning restrictions. "Kennel" as used in this subsection, means any establishment wherein or whereon dogs are kept for breeding, selling or sporting purposes. No premises shall be allowed as kennels if any buildings or enclosed dog yards or portions thereof are located closer than 300 feet to the nearest adjacent residential lot. (b) **Kennel License Applications**. The application for a kennel license shall state the name and address of the owner; the location of the proposed kennel; and the number of dogs proposed to be kept. Any person who keeps or operates a kennel may, in lieu of the individual license tax for each dog required by this section, apply to the Town Treasurer for a kennel license for the operation of such kennel. **The kennel license tax is \$ 65.00 (per 11/16/2019 Amendment to Ord.) for a kennel of 12 or fewer dogs and an additional \$ 3.00 for each dog in excess of 12. The license year shall commence on January 1 and end December 31.** (c) **Issuance of Kennel Tags**. Upon payment of the required kennel license tax, and upon presentation of evidence that all dogs over 5 months of age are currently immunized against rabies, the Treasurer shall issue a number of tags equal to the number of dogs authorized to be kept in the kennel. Tags shall be made in such form that they may readily be distinguished from the individual license tags for the same year. The owner or keeper of the kennel shall at all times, except during dog show competition or when the dog is confined indoors or in a fenced area, keep a kennel license tag attached to the collar of each dog over 5 months old kept under a kennel license.
