Re: Application of American Transmission Company LLC, as an Electric Public Utility, for a Certificate of Public Convenience and Necessity to Construct and Operate the Ozaukee Co. Enclosed is a copy of the complete application filed with the Public Service Commission (Commission) by American Transmission Company LLC (applicant). The application seeks authority to construct and place into operation the Ozaukee County Distribution Interconnection Project (project). Within the scope of the project, the applicant proposes 38-52 miles of new and updated 345 and 138 kilovolt (kV) transmission lines, varying between proposed routes, and the construction of new Decker, Adell, Mullet River Junction, Cedar Creek Junction, and Sheboygan River Junction substations in the counties of Ozaukee, Sheboygan, Washington, Calumet, and Fond du Lac, Wisconsin. Pursuant to Wis. Stat. § 196.491(3)(a) and Wis. Admin. Code § PSC 111.51(4), the Commission has directed the applicant to send an electronic copy of the application to the clerk of each municipality and town in which the proposed facility is to be located, and to the main public library in each county in which the proposed facility is to be located. Please provide the electronic copy, along with a copy of this letter, in an area where it will be available for public review until December 16, 2026.

Additional correspondence will also be provided to you, other interested parties, and all landowners potentially affected by the project. This correspondence will list your office as a location where the public may review the project application.
