- 6. Ten (10) copies of updated radius map showing all abutting properties (including those properties which are across a street from the subject property).
- 7. All submissions **MUST** include a digital copy (PDF format) of the Complete submission. (e.g. appeal package, survey, site plan, construction plans, etc.) on either a flash drive of CD-Rom, clearly labeled with the Applicant's name, address, Section, Block and Lot.

NOTE: Application for approval of Final Subdivision Plat shall be submitted <u>AFTER</u> preliminary approval is granted.
