## Minocqua Police Activity Report December, 2022

#### Incidents:

During the month of December, 2022, the Minocqua Police Department handled 394 incidents with an additional 306 calls for service from the public which involved dispatching Woodruff Police Department, fire and EMS. The 394 incidents also include calls self-initiated by officers of the Department. A breakdown of those calls in comparison to past years is as follows:
