## AN ORDINANCE RELATING TO GENERAL OFFENSES

The Town Board of the Town of Oakland, Jefferson County, Wisconsin, DO ORDAIN as follows:

Ordinance No. 9 is hereby repealed and recreated to read as follows:

# <u>Section 1</u> <u>Offenses Against State Laws Subject to For-</u>

The following statutes defining offenses against peace and good order of the State as now stated or hereafter amended are adopted by reference to define offenses against the peace and good order of the municipality provided the penalty for commission of such offenses hereunder shall be limited to a forfeiture imposed by the municipal court not to exceed \$500:

### Section 2 Sale and Discharge of Fireworks Restricted:

Section 167.10, Wis. Stats., as now stated or hereafter amended, regulating the sale and use of fireworks, exclusive of any penalty imposed thereby is adopted by reference and made part of this section as though set forth in full.

#### Section 3 Loud and Unnecessary Noise:

No person shall make or cause to be made any loud, disturbing or unnecessary sounds or noises such as may tend to annoy or disturb another in or about any public street, road, alley or park or any private residence.

# Section 4 Noise by Motor Vehicle Prohibited:

It shall be a violation of this section for a person to operate a motor vehicle so as to cause the tires thereof to squeal, the horn to blow excessively or the motor to race excessively.

# Section 5 Littering Prohibited:

No person shall throw any glass, rubbish, waste or filth upon the streets, roads, alleys, highways, public parks, or other property of the township or upon any private property not owned by him or upon the surface of any body of water within the township.

# Section 6 Obstructing Streets, Roads, or Highways:

No person shall stand, sit, loaf or loiter or engage in any sport or exercise on any public street, road, highway bridge or public ground within the township in such manner as to prevent or obstruct the free passage of pedestrian or vehicular traffic

thereon or to prevent or hinder free ingress to or from any place of business or amusement, church, public hall or meeting place.

#### Section 7 Removal of Ice from Lake Ripley:

Any person who shall remove ice from Lake Ripley shall place around the margin of the opening or openings made by such removal, a fence by setting posts not less than two inches by four inches (2"x4") in size, and a fence board thoroughly nailed thereto, not less than three and one-half feet  $(3\frac{1}{2})$  above the surface of the ice on such lake.

#### Section 8 Reckless Driving on Lake Ripley:

No person shall operate a motor vehicle on the ice on Lake Ripley in such a manner as to endanger the welfare of any person or persons. Included in this section is the damage or endangering of property while driving in a reckless manner on the ice of Lake Ripley.

## Section 9 Liquor on Public Ways Prohibited:

No person shall have in his/her possession any open can, bottle or other container containing malt beverages, or intoxicating liquor, or drink from the same, on any public way, street, road, alley or public parking lot. Included is a parked motor vehicle on a public way, street, road, alley or public parking lot. The Town Board may grant temporary exemptions from this section for such time and at such places as they may specifically designate.

# Section 10 Issuance of Worthless Checks:

- (A.) Whoever issues any check or other order for the payment of money less than Five Hundred Dollars (\$500.00) which at the time of issuance, he/she intends shall not be paid, is guilty of a violation of this section, and the penalties for such actions are set forth below.
- (B.) Any of the following is prima facie evidence that the person at the time he/she issued the check or other order for the payment of money intended it should not be paid:
  - (1) Proof that, at the time of issuance, the person did not have an account with the drawee, or
  - (2) Proof that, at the time of issuance, the person did not have sufficient funds or credit with the drawee and that the person failed within five (5) days after receiving notice of nonpayment or dishonor to pay the check or order; or
  - (3) Proof that, when presentment was made within a reasonable time, the person did not have sufficient

funds or credit with the drawee and the person failed within five (5) days after receiving notice of nonpayment or dishonor to pay the checks or other order.

- (C.) The penalties to be imposed for a violation of this section are as follows:
  - (1) Any person violating any provision of this section shall forfeit not less than Twenty Dollars (\$20.00) nor more than Five Hundred Dollars (\$500.00), together with the costs of prosecution, and in default of payment of said forfeiture and costs of prosecution shall be incarcerated in the Jefferson County Jail until such forfeiture and costs of prosecution are paid, but not to exceed ninety (90) days.

Section 11 Effective Date.

This ordinance shall take effect and be in force from and after its passage and publication and/or posting.
