## ORDINANCE NO. 1

## AN ORDINANCE TO AMEND ORDINANCE REGULATING VEHICULAR TRAFFIC IN THE TOWN OF OAKLAND

The Town Board of the Town of Oakland, Jefferson County, Wisconsin, DO ORDAIN that Ordinance Number 1 of the Town of Oakland is hereby amended to read as follows:

## Section 2. <u>Establishment of Maximum Permissible Speeds</u>

Section 2, Paragraph (A), shall be repealed and recreated to read as follows:

(A) Park Road. Speed limit shall be 30 miles per hour for all vehicles from its intersection with U.S. Highway 12, northeasterly to its intersection with U.S. Highway 18.

Section 2, Paragraphs (X) through (KK), shall be created to read as follows:

- (X) <u>Prairie Rose Road</u>. Speed limit shall be 25 miles per hour for all vehicles from its intersection with Old Forest Road, northerly and westerly to its end.
- (Y) Old Forest Road. Speed limit shall be 25 miles per hour for all vehicles from its intersection with U.S. Highway 18, westerly and northerly to its end.
- (Z) <u>Tall Pines Place</u>. Speed limit shall be 25 miles per hour for all vehicles from its intersection with Prairie Rose Road, easterly to its end.
- (AA) Overlook Court. Speed limit shall be 25 miles per hour for all vehicles from its intersection with Prairie Rose Road, easterly to its end.
- (BB) Roads End Court. Speed limit shall be 25 miles per hour for all vehicles from its intersection with Prairie Rose Road, northeasterly to its end.
- (CC) <u>Wilderness Place</u>. Speed limit shall be 25 miles per hour for all vehicles from its intersection with Old Forest Road, westerly to its end.
- (DD) <u>Hidden Valley Place</u>. Speed limit shall be 25 miles per hour for all vehicles from its intersection with Old Forest Road, southwesterly to its end.
- (EE) <u>Applegate Lane</u>. Speed limit shall be 25 miles per hour for all vehicles from its intersection with Red Feather Drive, northerly to its end.

- (FF) Red Feather Drive. Speed limit shall be 25 miles per hour for all vehicles from its intersection with Blue Spruce Lane, westerly, southerly, and southeasterly to its intersection with Wolff Road.
- (GG) <u>Blue Spruce Lane</u>. Speed limit shall be 25 miles per hour for all vehicles from its intersection with Red Feather Drive, easterly to its end.
- (HH) <u>Bluewaters Pass</u>. Speed limit shall be 25 miles per hour for all vehicles from its intersection with Wolff Road, westerly to its intersection with Red Feather Drive.
- (II) <u>Blue Spruce Lane</u>. Speed limit shall be 25 miles per hour for all vehicles from its intersection with Bluewaters Pass, northerly to its end.
- (JJ) <u>Forested Road</u>. Speed limit shall be 25 miles per hour for all vehicles from its intersection with Island Lane, northeasterly to its end.
- (KK) <u>Marshview Court</u>. Speed limit shall be 25 miles per hour for all vehicles from its intersection with Forested Road, southerly to its end.

The Town Board DO FURTHER ORDAIN that this Ordinance shall be effective upon adoption, publication, approval and erection of signs as provided by law.
