- 2. NPAHD representative, Michael Waggoner gave members a handout of the previous meeting financial report and mentioned the merger with Marshfield and Essentia has been dissolved. He mentioned how tax dollars from townships east of the 35 corridor are being provided with food service for whomever shows up with no guidelines or equal consideration for those who are paying the bill. Recently such events have been held in and on the usual corridor and not a nickel of the mandated contribution has ever been spent for such activity East of the corridor. It is easy to understand why the majority of eligible Pine County townships have not joined the NPAHD effort. The 1989 mission has been accomplished. The Sandstone Hospital, 35 years later, is now profitable and part of a \$ 5+ billion-dollar enterprise. It is time to unshackle hundreds of landowners/taxpayers who are continuing to fund the "save the hospital" mission. Suggestion was made to move forward and sell the property, which the taxpayers have funded and saved to a point of profitability and is secure regarding its continuation as a health/hospital facility.
