Outdoor and Refuse Burning No. 07-15-01	Of ordinance	Not less than \$100 and not more than \$300	\$100 plus \$163.50=\$263.50
Town Animal Control No. 21-15-02	Of Ordinance	Not less than \$50 and not more than \$500	\$50 plus \$150.50=\$200.50
Driveway and Highway Access No. 12-15-08	Of Ordinance per day	Not less than \$50 and not more than \$400	\$50 plus \$150.50=\$200.50
Prohibiting Engine Braking No. 23-15-04	Of Ordinance per occurrence	Not less than \$50 and not more than \$250	\$50 plus \$150.50=\$200.50
Fireworks No. 16-15-01	Of Ordinance per occurrence	Not less than \$100 and not more than \$500	\$100 plus \$163.50=\$263.50
Cemetery No. 19-15-01	Of Ordinance	Not less than \$100 and not more than \$500	\$100 plus \$163.50=\$263.50

ATV/UTV No. 23-15-02	Of Ordinance per occurrence	Not less than \$50 and not more than \$250	\$50 plus \$150.50=\$200.50
Road Right of Ways No. 19-15-05	Of Ordinance per day	Not less than \$100 and not more than \$500	\$100 plus \$163.50=\$263.50
Waste Management Ordinance No. 19-15-06 Section 1 Solid Waste Collection	Of Ordinance per occurrence per day	Not less than \$100 and not more than \$300	\$100 plus \$163.50=\$263.50
Waste Management Ordinance No. 21-15-03 Section 2 Yard Waste	Of Ordinance per occurrence	Not less than \$10 and not more than \$500	\$10 plus \$140.10 = \$150.10
Subdivision Code Ordinance No. 23-15-03	Of Ordinance per occurrence	Not less than \$100 and not more than \$250	\$100 plus \$163.50=\$263.50

Deposits shall be made in cash, money order or certified check to the Eau Claire County Clerk of Courts who shall provide a receipt therefore.
