The fall harvest season is right around the corner. Please be careful of farm equipment on the roads and give them plenty of space. Did you know that the Town of Pleasant Valley is comprised of 33,554 acres, of which 31,358 are zoned for agricultural use?

## **Garbage Can Placement**

We continue to have issues with garbage cans being placed in the traveled portion of the roadway. For safety reasons, please make sure your garbage cans are placed off the traveled portion of the roadway, in or next to your driveway and not across the road from your driveway. If your hauler requests anything different, they are in violation of Town Ordinance 24-15-03 Section4.1.1 "The hauler must require the container be placed in the driveway of the customer, off of the traveled portion of road. Haulers may not request customers to place any collection container across the road

from the resident being serviced by said hauler."



## **Generator Project Update**

The Town, along with the Cleghorn Lions and Township Fire Department are working to secure funds to upgrade the Town Municipal building with a generator that will serve the entire building should the power fail. The Community Center will be equipped to serve displaced residents from Pleasant Valley and other surrounding communities in the case of a disaster. Town Government will continue to operate and the fire department will have full operations of their equipment and garage doors. This is an expensive project. Eau Claire County offers free recycling drop off at various locations throughout the county. The recycle center in Pleasant Valley is located across from the fire station at S10405 Cty Rd HHI in Cleghorn. Eau Claire County employs attendants at this site. Regular hours are the 2nd and 4th Saturday of each month between the hours of 8-noon. Accepted recyclables are the same as curbside recycling: cardboard, cans, glass and certain plastic containers. 
If you live in a Residential District and are interested in having chickens under the new county ordinance, check out their website for resources on applying for a license and keeping your backyard flock healthy.

#### **Well Water Testing**

The City County Health Department has water testing supplies available for residents in the county. Even without a change in color, smell, or taste of the water, many things like bacteria, nitrate, and metals can negatively affect your family's health. Last year 1 in 6 drinking water samples from Eau Claire County private wells tested positive for harmful bacteria. If you have a private well, yearly tests for at least bacteria and nitrate are recommended. Water test results are for your knowledge only. If your water result is unsafe, you can decide to treat your water or not. Visit the Eau Claire City-County Health Department website for more information.
