From the Village Hall

General Election: There will be a General Election on **Tuesday, November 8, 2016** for President/Vice President, United State Senator, Federal Representative in Congress, State Representative to the Assembly, State District Attorney, County Clerk, County Treasurer and County Register of Deeds. Polls will be open at the Reedsville Municipal Building, 217 Menasha St., from 7:00 am until 8:00 pm. In order to receive ballot, you must be registered and provide a photo ID.

What are the requirements to register to vote or update a voters' registration?

- ⇒ In Wisconsin you have to be at least 18 years old on or before the NEXT election. The next state-wide election is November 8, 2016, so anyone who is now 17 and has a birthday on or before November 8, 2016, can register now if they meet the rest of the requirements.
- ⇒ You must be a U.S. Citizen, not currently serving a felony conviction (either jail time or probation), nor been declared incompetent or ineligible to vote by a judge.
- ⇒ You must have resided in your home for at least 10 days prior to Election Day in order to establish a new voting location.
- ⇒ You must show Proof of Residency; an acceptable document that proves you reside (live) where you say you reside. The most commonly used acceptable documents include: a current and valid driver's license or state ID issued by the Wisconsin DMV, a recent utility bill (gas, electric, phone, TV cable or satellite, or internet – not credit card), a paycheck or pay stub, and a bank or credit union statement. The utility bill, paycheck, paystub, or banking statement can be shown either as a paper document or in electronic format.

The following photo IDs are acceptable for voting purposes:

1. Unexpired or expired after November 6, 2012:
 - ◇ A Wisconsin DOT-issued driver license, even if expired, revoked or suspended.
 - ◇ A Wisconsin DOT-issued identification card
 - ◇ Military ID card issued by a U.S. uniformed service (veteran ID card not included)
 - ◇ A U.S. passport book or card
2. Must be unexpired:
 - ◇ A certificate of naturalization that was issued not earlier than two years before the date of an election at which it is presented
 - ◇ A driver license receipt issued by Wisconsin DOT (valid for 45 days)
 - ◇ An identification card receipt issued by Wisconsin DOT (valid for 45 days)
 - ◇ An identification card issued by a federally recognized Indian tribe in Wisconsin
 - ◇ A photo identification card issued by a Wisconsin accredited university or college that contains the following:
 - Date of issuance
 - Signature of Student
 - Expiration date no later than two years after date of issuance
 - The university or college ID must be accompanied by a separate document that proves enrollment

THE HISTORY OF OUR HEARTS

Winter Parking Restrictions: No person shall park any vehicle on any street or alley in the Village between two-thirty (2:30) am to six (6) am of any day from **November 1** to April 1.

Sump Pumps: No discharge or overflow of storm water shall be permitted upon any street or public way from **November 1** to April 1 of each year.

Exemplary Accreditation—St. John - St. James Lutheran School

To be granted **full accreditation** by WELSSA, a school must meet 85% of the national standards set forth by WELSSA. To receive **exemplary accreditation**, you must meet 95% of the standards. Today, St. John - St. James is proud to announce: *St. John - St. James School's K-8 program has met 96% of those standards and will be recommended by the site visit team to be granted **EXEMPLARY ACCREDITATION!***

St. John - St. James 3K-4K program was granted provisional accreditation. It has also met 96% of those standards; however, we have to make one modification to one required standard. Once this is taken care of our program will be recommended for **EXEMPLARY ACCREDITATION in September of 2017!**

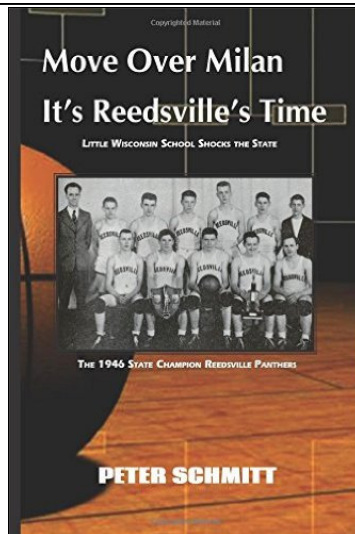

Town Web Design regarding Upgrading the Website and Facebook. A motion was made by Lorrigan and seconded by Siebert to budget this for 2017. Motion carried 4-0

Deyo Disposal Inc. regarding the Village Wide Clean-Up Day. A motion was made by Reis and seconded by Lorrigan to table the discussion and to send a letter to Deyo letting them know this. Motion carried 4-0.
