Partisan Primary Election: There will be a Partisan Primary Election on **Tuesday, August 9th** for Governor, Lieutenant Governor, Attorney General, Secretary of State, State Treasurer, United State Senator, Representative in Congress, State Senator, Representative to the Assembly, County Sheriff, County Coroner and County Clerk of Circuit Court.

At this Partisan Primary Election, you may only vote for candidates in **ONE** political party.

Polls will be open at the Reedsville Municipal Building, 217 Menasha St., from 7:00 am until 8:00 pm. You must show an acceptable form of photo identification to receive a ballot.

To ensure you are properly registered or to apply for an absentee ballot, please visit myvote.wi.gov.

E-Mail Water Bills: If you are interested in receiving your monthly water bills via e-mail (instead of a paper bill in the mail) you can pick up the form in the lobby of the Reedsville Municipal Building or on the website under Forms and Permits, "Paperless Utility Billing Form" and return it to the Clerk-Treasurer's Office.

Camper & Trailer Parking: Please be aware of where you are parking your campers and trailers, especially by intersections. Safety of our residents is the main concern.

Thursday, June 9th, 2022

6:30 pm

1. Call to order

The monthly meeting of the Reedsville Village Board was called to order on June 9, 2022, at 6:30 PM by Village President Jesse Walt.

2. Pledge of Allegiance

3. Roll call

4. Approval of Agenda

A motion was made by Siebert and seconded by Maertz to approve the agenda as presented. Motion carried -0.

5. Public Appearances

a. Public Input: None

b. Visitors: None

6. Approval of Minutes

A motion was made by Maertz and seconded by Hansen to approve the May 12, 2022 meeting minutes as presented. Motion carried 6-0.

7. Treasurer's Reports/Bills

A motion was made by Be Busse and seconded by Fox to pay the accounts payable in the amount of \$55,706.26. Motion carried 6-0.

8. Correspondence

a. Valders Ambulance Service Report - May 2022

b. A motion was made by Be Busse and seconded by Fox to approve the Street Closure Application from the Reedsville Firefighters. Motion carried 6-0.

c. Two letters of Noncompliance from the Dept of Natural Resources were presented for review.

9. Department Reports

1. Fire Department

Fire Chief Jason Schuh submitted a written report.

May total calls - 5 Yearly Total - 28

i. A motion was made by Siebert and seconded by Be Busse to approve the Fire Dept Application from Kyle Stotzheim. Motion carried 6-0. Final approval will be given upon passing of classes and a physical.

2. First Responders

First Responders President, Mike Kocourek submitted a written report.

3. Utility Department

Utility Operator, Tanner Raddatz, submitted a written report

i. The discussions on the sewer back-up, WWTP Facility Plan and the Well #3 project were postponed until next regular scheduled Village Board meeting.

ii. The replacement of the WAS Flow Meter will be done during the upgrade project.

iii. A motion was made by Rataichek and seconded by Be Busse to accept the proposal from Hietpas & Sons Inc to install the 8" valve at the lift station in a lump sum amount of \$5,900.00. Motion carried 6-0.

iv. Siebert introduced Resolution 2022 regarding the Compliance Maintenance Annual Report. A motion was made by Be Busse and seconded by Hansen to approve the Resolution as presented. Motion carried 6-0.

v. Krahn explained the interest and ability for e-mailing the water bills. This will start with the July billing.

4. Public Works

John Schuh, PW Supervisor submitted a written report.

i. The upgrade on the USDS project was postponed until the next regular scheduled Village Board meeting.

ii. A motion was made by Fox and seconded by Hansen to approve the request from Debra Hansen to have ducks on her property. Motion carried 4-1 (Be Busse abstained, Maertz opposed)

iii. Following a discussion, it was decided to see if the organizations involved could get together to discuss the Hardball Field.

iv. The discussion on the variance request from John Mangin was postponed until the next regular scheduled Village Board meeting.

v. A notice will be put in the Reedsville News asking residents to be aware of where they are parking their campers and trailers. Safety of residents is the main concern of this issue.

5. Clerk-Treasurer — Mary Jo Krahn

i. A motion was made by Fox and seconded by Maertz to charge non-profit organizations within the Village \$10.00 and outside of the Village \$15.00 for a business card size ad in the Reedsville News. Motion carried 6-0.

ii. A motion was made by Be Busse and seconded by Rataichek to approve the Class A Combination License Application for the Country Vision Coop, C-Store. Motion carried 6-0.

iii. A motion was made by Be Busse and seconded by Rataichek to approve the Class B Beer License Application from Reedsville Athletic Assn for Bubolz Memorial Park, and Park Street Concession Stands. Motion carried 6-0.

iv. A motion was made by Be Busse and seconded by Rataichek to approve the Class B Combination License Applications for Manitowoc Street Pub, Mud Creek Tap, and the Reedsville Firefighters. Motion carried 6-0.

v. A motion was made by Be Busse and seconded by Rataichek to approve the Temporary Class B License Application from the Reedsville Flames. Motion carried 6-0.

vi. A motion was made by Be Busse and seconded by Rataichek to approve the Soda License Applications from Manitowoc Street Pub, Mud Creek Tap, Reedsville Athletic Assn (Bubolz Memorial Park & Park Street Concessions) Country Vision Coop, C-Store, Reedsville Firefighters, Jim's Service and Car Wash LLC, Equity Coop, Reedsville Flames, and S&K Café. Motion carried 6-0.

vii. A motion was made by Be Busse and seconded by Rataichek to approve the Tobacco Product License Application for the Country Vision Coop, C-Store. Motion carried 6-0.

viii. A motion was made by Be Busse and seconded by Rataichek to approve the Operator License Applications for Casey Schmitt, Nicole Dirden, Nancy Sterleske, Theodore Sterleske, Daniel Vogel, David Schuh, Mary Schneider, Melissa Cassidy, Marian Koch, Sheila Reznichek, Amanda Sculley, Thomas Wenzel, Linda Wenzel, Susan Haese, Autumn Walczak, Stephanie Stiefvater, John Hammarlund Jr., Sarah Lemke, Melisa Kalies, Cheryl Brazil, Andrew Krueger, Brianne Hansen, Derick Klein, and Stacy Kurtz. Motion carried 6-0.

ix. Siebert introduced Ordinance 2022-3 adopting the Development Ordinance. A motion was made by Rataichek and seconded by Fox to approve the Ordinance as presented. Motion carried 6-0.

x. A Letter of Resignation was presented from Stephanie Stiefvater. A motion was made by Be Busse and seconded by Fox to accept the resignation. Motion carried 6-0.

Police Chief, Kirk Schend, submitted was written report.

10. At 7:55pm a motion was made by Siebert and seconded by Hansen to convene into CLOSED Session, pursuant to WI Statute Section 19.85(1)(f) to conduct business which requires a closed session to consider data of specific persons. Motion carried 6-0.

11. At 7:58pm a motion was made by Be Busse and seconded by Siebert to reconvene into OPEN SESSION. Motion carried 6-0.

12. A motion was made by Be Busse and seconded by Fox to have the meter tested to see if it is working correctly at the residence. Motion carried 6-0.

13. At 7:59pm a motion was made by Be Busse and seconded by Fox to convene into CLOSES Session, pursuant to WI Statute Section 19.85(1)(c) to conduct business which requires a closed session to consider employment and compensation for any public employee over which the government body has jurisdiction. Motion carried 6-0. Krahn was asked to leave the session.

14. At 9:15pm a motion was made by Rataicek and seconded by Fox to reconvene into OPEN SESSION. Motion carried 6-0. Krahn returned to the meeting.

15. Upcoming Meetings:

i. A special meeting was scheduled for Thursday, June 16, 2022 at 5:30pm to view the Wastewater Treatment Facility and Wells.

ii. The next regular monthly meeting will be held on Thursday, July 14, 2022 at 6:30 pm.

16. Adjournment: A motion was made by Rataichek and seconded by Fox to adjourn the meeting. Motion carried 6-0. Meeting adjourned at 9:24 PM.
