

Thank You! On behave the citizens of the Village and the Village Board, we would like to say thank you to Jesse Walt for his many years of service as Village President.

Building Identification Number: The owner of every principal structure on each lot in the village shall have displayed on the side of the structure facing the adjoining public right of way numbers not less than four inches (4") in height showing the street number assigned to that property by the village. Numbers in script shall not meet the requirements of this section. The owner of such structure shall keep the numbers clear and unobstructed so that they can be readily seen by a person of ordinary eyesight from the adjoining public right of way.

Bicycle Registration: All bicycles must be registered. To obtain the license, flag down a Village Police Officer. A \$2.00 fee covers a one-time registration.

Open Book: The Village of Reedsville Assessment Roll will be available for examination on Monday, May 1, 2023, 3:30 pm to 5:30 pm in the hall of the Reedsville Municipal Building, located at 217 Menasha Street. To schedule a time to discuss an assessment with the Village Assessor, please contact the Village Clerk-Treasurer at 920-754-4371 during normal business hours.

Board of Review: The Village of Reedsville will hold its Board of Review on Wednesday, May 17, 2023 from 3:30 pm to 5:30 pm in the hall at the Reedsville Municipal Building located at 217 Menasha Street. Please contact the Clerk-Treasurer at 754-4371 for the procedural requirements if you would like to appear before the Board.

Curfew: Any person under the age of 18 unaccompanied by a parent or legal guardian may not be out and about between 11:00 PM - 6:00 AM Sunday through Thursday and 12:00 PM - 6:00 AM Friday and Saturday.

Vehicle Nuisance: It is illegal for any partially dismantled, non-operating, wrecked, junked, unregistered or discarded vehicles to be placed or stored on any public or private property within the Village limits for a period of longer than five (5) days, unless said vehicles are stored within an enclosed building. This ordinance does not apply to property zoned for the sale or repair of vehicles. Having a vehicle behind your garage or under a tarp does not meet the requirement of an enclosed building.

Open Burning/Fire Pits: Controlled burning must be located off the public street pavement or street gutter, must be as least fifteen (15') from any lot line and may not be less than fifteen feet (15') from any building. Only clean wood may be used in fire pits and flames cannot extend more than two feet (2') above the pit. All fires must be monitored by a responsible person until the fire has extinguished itself completely. Persons utilizing and maintaining outdoor fires shall be responsible for any liability resulting from any damage caused by their fire.

Pool Owners: You must fill out the **Swimming Pool Discount Application** to qualify for the swimming pool discount. No other form of submittal will be accepted. This form can be found on the Reedsville website **www.reedsvillewi.gov** or picked up at the Reedsville Municipal Building Lobby.

Dogs or Cats: It shall be unlawful to own, harbor, shelter, of keep any dog or cat which runs at large within the limits of the Village. A dog or cat shall be deemed to be running at large when it is on any public street, alley, parks, or other grounds of the Village or any other premises in the Village other than the premises of its owner, his servant, agent or a member of his family of suitable age and discretion unless it is on a durable leash no longer than eight feet (8') or the dog or cat must be under control and within eight feet (8') of its owner, his servant, agent or a member of his family of suitable age and discretion at all times when off the premises of its owner.

It shall be unlawful for any person owning or in control of a dog or cat to allow or permit such animal to defecate on any private or public property owned by another unless such person shall remove all feces so deposited by such animal. Violation shall be punishable by a forfeiture of not less than twenty dollars (\$20.00) nor more than two hundred dollars (\$200.00).

Littering in Streets Prohibited: No person shall place, throw, deposit, dump, scatter, leave or permit to remain any rubbish, paper, stone, wire, manure, snow, ice, dirt, grass, leaves, construction or yard waste, dirt or filthy substance upon the street, gutter, sidewalk, alley or public ground in the village. Each owner or occupant of any building, dwelling house, store, shop, tenement or structure of any kind and description fronting or abutting on any street, sidewalk, gutter, alley or public ground shall clean the same by sweeping, scraping or shoveling such rubbish, dirt or filth from the sidewalk by or before twelve o'clock (12:00) noon of each day, and shall cooperate with the street commissioner in keeping the streets, alleys, gutters and public grounds in a clean, tidy and orderly manner.

Signs and Awnings: No signs, posters or other advertising material shall be placed in or on any village owned property without permission from the Public Works Director.

1. Call to order

The monthly meeting of the Reedsville Village Board was called to order on March 9, 2023, at 6:30 PM by Village President Jesse Walt.

2. Pledge of Allegiance

4. Approval of Agenda

A motion was made by Fox and seconded by Reedy to approve the agenda as presented. Motion carried 5-0.

5. Public Appearances

b. Visitors: Kayla Kiekhaefer read a statement regarding Village Board meetings, picking up dog messes, and street parking

6. Approval of Minutes

a. A motion was made by Rataichek and seconded by Hansen to approve the February 9, 2023 meeting minutes. Motion carried 5-0.

7. Treasurer's Reports/Bills

A motion was made by Rataichek and seconded by Siebert to pay the accounts payable in the amount of \$100,405.16. Motion carried 5-0.

A motion was made by Siebert and seconded by Rataichek to approve the Operator License applications from Madisyn Morales, Melisa Shamburek, Luciano Camacho-Lopez and Amy Isajiw. Motion carried 5-0. e. A motion was made by Rataichek and seconded by Fox to approve the Temporary Class B License application from the Reedsville Fire Fighters. Motion carried 5-0.

iii. A discussion was held regarding assistance on calls.

i. C Schuh gave an update on the WWTP Facility Plan and Well #3 Project

ii. The teleconference with the Dept. of Natural Resources will be attended by Ja Maertz, C. Schuh and Jesse Walt.

iii. A motion was made by Fox and seconded by Reedy to approve the Engineering Service proposal from Ayres Assoc to submit the loan application for the Well #3 project. Estimated cost to be \$18,000.00. Motion carried 5-0.

iv. A motion was made by Rataichek and seconded by Hansen to approve the three (3) employees to go to the cross connection training on March 21, 2023 in the amount of \$330.00. Motion carried 5-0.

v. A motion was made by Rataichek and seconded to send Ja Maertz and Raddatz to the WRWA conference in the amount of \$690.00 plus hotel. Motion carried 5-0

4. Clerk-Treasurer — Mary Jo Krahn

i. A motion was made by Fox and seconded by Reedy to approve the proposed building permit fees with the changes. Motion carried 5-0.

ii. A motion was made by Fox and seconded by Reedy to increase the street excavating fee to \$100.00. Motion carried 5-0.

iii. A motion was made by Hansen and seconded by Fox to increase the building materials fee to \$150.00. The public works dept will need to take pictures of the Street before the materials can be put down. Motion carried 5-0.

iv. A motion was made by Siebert and seconded by Fox to increase the sign and awning permit fee to \$100.00. Motion carried 5-0.

v. A motion was made by Fox and seconded by Siebert to increase the Televising Refusal and failure to correct fee to \$100.00 a month. Motion carried 5-0.

vi. A motion was made by Reedy and seconded by Fox to increase the Transient permit loss fee to \$25.00. Motion carried 5-0.

vii. A motion was made by Reedy and seconded by Fox to eliminate the Fire Permit fee. Motion carried 5-0.

viii. Additional ordinance changes will be prepared for the next regular scheduled Village Board meeting.

ix. Following a discussion, a motion was made by Fox and seconded by Hansen to send the Street Parking Ordinance draft to the Village Attorney for their review. Motion carried 3-2 (Siebert and Rataichek opposed)

x. The Tourist Lodging Ordinance was introduced by Rataichek. A motion was made by Siebert and seconded by Fox to approve the Ordinance as presented. Motion carried 5-0.

xi. The 2022 Tax Collection Report was presented for Board information.

xii. Following a discussion, it was decided to spend no more time on collecting the grass cutting fees on the Frontier property.

xiii. A motion was made by Hansen and Fox to change the Clerk-Treasurer office hours to Monday thru Friday 8:00am until 4:00pm with summer hours (May 1 to September 30) Monday thru Friday, 8:00am until 4:00pm and Friday 8:00am until 1:00 pm. Motion carried 5-0.

5. President Report — Jesse Walt

i. The discussion on the AT&T payment was postponed until the next regular scheduled Village Board meeting.

6. Police Department

Police Chief, Kirk Schend, submitted a written report.

10. 7:50pm Convene into CLOSED Session, a motion was made by Siebert and seconded by Hansen to convene into closed session, pursuant to WI Statute Section 19.85(1)(c) to conduct business which requires a closed session to consider performance evaluation data of any public employee over which the governmental body has jurisdiction or exercises responsibility. Motion carried 5-0.

11. 7:55 pm Reconvene into OPEN Session, a motion was made by Rataichek and seconded by Hansen to convene into open session. Motion carried 5-0.
