Health Information

Educational Information

The sources of drinking water, both tap water and bottled water, include rivers, lakes, streams, ponds, reservoirs, springs and wells. As water travels over the surface of the land or through the ground, it dissolves naturally occurring minerals and, in some cases, radioactive material, and can pick up substances resulting from the presence of animals or from human activity.

Contaminants that may be present in source water include:

- Microbial contaminants, such as viruses and bacteria, which may come from sewage treatment plants, septic systems, agricultural livestock operations and wildlife.
- Inorganic contaminants, such as salts and metals, which can be naturally- occurring or result from urban stormwater runoff, industrial or domestic wastewater discharges, oil and gas production, mining or farming.
- Pesticides and herbicides, which may come from a variety of sources such as agriculture, urban stormwater runoff and residential uses.
- Organic chemical contaminants, including synthetic and volatile organic chemicals, which are by-products of industrial processes and petroleum production, and can also come from gas stations, urban stormwater runoff and septic systems.
- Radioactive contaminants, which can be naturally occurring or be the result of oil and gas production and mining activities.

In order to ensure that tap water is safe to drink, EPA prescribes regulations that limit the amount of certain contaminants in water provided by public water systems. FDA regulations establish limits for contaminants in bottled water, which shall provide the same protection for public health.

Additional Health Information

If present, elevated levels of lead can cause serious health problems, especially for pregnant women and young children. Uncorrected Significant Deficiencies

SD1 The Village has not addressed a deficiency identified in the department's 2019 Sanitary Survey. As a result, this deficiency has been elevated to significant and failure to complete the required corrective actions will result in a Treatment Technique Violation (TTV) in accordance with section NR 809.328(1), Wis. Adm. Code. In the 2019 Sanitary Survey the department noted the following deficiency, Dead ends shall be minimized by looping mains whenever possible. Where dead end mains occur, they shall terminate with a fire hydrant, if flows and pressures are sufficient or with an approved flushing hydrant or blow off for flushing purposes in accordance with s. NR 811.70(8), Wis. Adm. Code. This requirement is in place to minimize water quality issues that arise from stagnant water in mains. In response to the 2019 Sanitary Survey report, the Village agreed to install hydrants during the 2020 construction projects; however, this work was never completed.	6/9/2022	12/1/2023

Actions Taken

We added a flushing hydrant at the end of north 5th street during the 2020 street project. Once that was finished all dead ends had either a hydrant, flushing hydrant or looped together.
