Meetings/Training Attended

During the month of April, officers completed Emergency Medical Responder refresher training. I attended a meeting with the District Attorney, the annual meeting, staff, PFC, and Town Board meetings.

Calls for Service, Citations, and Written Warnings

During the month of April, officers handled 149 calls for service, issued 54 citations and 28 written warnings.

Department Activities/Announcements

The 2023 Dodge Charger is ready to go into service once the computer is received. The UTV was upfitted during the month and will be ready for use in May.

Buoys are being placed for the 2023 boating season. They will all be in place by the Memorial Holiday weekend. Boat patrol Officer training was held in April.

I would like to inform residents it is that time of year again when the Rome Police Department starts to receive complaints on fireworks. The police department will have a zero tolerance for illegal discharge of fireworks. A commonly used rule of thumb is that if the device explodes or leaves the ground it is unlawful to discharge without a permit. The permits issued at many roadside stands indicate a specific place for the discharge of the fireworks. NONE of those are in the Town of Rome, so any discharge would be illegal and subject to a \$250.00 fine and confiscation of the fireworks.

Routine maintenance was done to the fleet in April.
