Rome Police Department Monthly Report June 2023

Meetings/Training Attended

During the month of June, I attended a meeting with the Adams County Judges, changes were made to the Adams County bail protocols. I also attended PFC and Department Head meetings in June. I held a staff meeting with full-time P.D. staff to cover the new bond protocols.

Calls for Service, Citations, and Written Warnings

During the month of June, officers handled 206 calls for service, issued 91 citations, and 62 written warnings. The Boat patrol logged 33.5 hours of patrol in June. Several warnings were issued and one citation.

Department Activities/Announcements

Each year the State of Wisconsin requires every police officer to attend at least 24 hours of training to maintain their certification as a law enforcement officer. The fiscal year for this requirement ended on June 30th. I would like to report that all officers in the Rome Police Department met this requirement by exceeding 24 hours of professional development. I have submitted the training compliance report to the Wisconsin Training and Standards Bureau. T&S will reimburse the Town of Rome for each officer that completed the minimum 24-hours of training.

Officer Chersini resigned from the boat patrol in June. Officer Keifpher Ballweg was hired to replace her.

Boaters, please take the time to read the current boating law handbook prior to hitting the water this summer. Please follow all the rules to have a safe and enjoyable boating season. Here is the link to the current handbook <https://widnr.widen.net/s/0vw8hwrae3>.

In addition, the Town of Rome has local regulations. Motorboat operation is restricted to Slow-No-Wake after 8pm thru sunrise. No personal watercraft shall be operated at a speed greater than slow-no-wake before 10:00 a.m. or after 8:00 p.m. Water skiing, wake surfing, or being towed on other devices, shall be limited to the daylight hours between 10:00 a.m. and 8:00 p.m. or sunset whichever comes first. The regulations are in place to ensure everyone's safety on our lakes. If you see individuals violating the rules, or operating in an unsafe manner, please report it immediately by calling 877-885-9977 option 0.

We have been receiving complaints of boat traffic and water skiing after 8:00 pm on Lakes Camelot, Sherwood, and Arrowhead. As a reminder, these lakes are all slow no wake after 8:00 pm. If residents observe boating violations, we urge them to call in the violations so we can give these problem areas some extra attention. Reports can be made by calling 877-885-9977 option 0.

Routine maintenance was done to the fleet in June.
