Rome Police Department Monthly Report July 2023

Meetings/Training Attended

During the month of July, Officers attended firearms qualification training in Adams. I attended a staff meeting.

Calls for Service, Citations, and Written Warnings

Officers handled 227 calls for service, issued 93 citations, and 76 written warnings. The Boat Patrol logged 178.5 hours of patrol, issued 24 citations and 20 warnings.

Department Activities/Announcements

As a reminder, State law prohibits boat and watercraft operation at a speed faster than slow no wake within 100 feet of any dock raft or pier. State law also prohibits personal watercraft from traveling faster than slow no wake within 200 feet of shore.

Also, as a reminder Lakes Camelot, Sherwood, and Arrowhead are all slow no wake after 8:00 pm. If residents observe boating violations, on a routine basis, we urge them to call the Rome Police Department so we can give these problem areas some extra attention.

The Rome Police Department will have a zero tolerance for illegal discharge of fireworks. A commonly used rule of thumb is that if the device explodes or leaves the ground it is unlawful to discharge without a permit. The permits issued at many roadside stands indicate a specific place for the discharge of the fireworks. NONE of those are in the Town of Rome, so any discharge would be illegal and subject to a \$250.00 fine and confiscation of the fireworks. If you observe illegal fireworks discharge, please report the violations by calling 1-877-885-9977.

Squad 85 was involved in a car deer crash, the repairs are scheduled for August. Routine maintenance was done to the remainder fleet during July.
