## Rome Police Department Monthly Report August 2023

### **Meetings/Training Attended**

During the month of August, Sgt. Upton attended a use of force instructor training. Officer Aldrich is attending emergency medical responder training. I attended an Adams County Traffic Safety meeting.

### **Calls for Service, Citations, and Written Warnings**

Officers handled 160 calls for service, issued 109 citations, and 94 written warnings. The Boat Patrol logged 102 hours of patrol, issued 18 citations, and 20 warnings.

### **Department Activities/Announcements**

The boat patrol will conclude their seasonal duties on Labor Day weekend. Final numbers will be totaled and reports completed for the DNR. The patrol program has had another successful year with no serious injuries or fatalities reported on our lakes. I would like to thank the boat patrol officers for all their hard work throughout the summer.

The Community Service Officer (CSO) will be focused on property violations, to include dead brush and timber, throughout the town this fall. The assigned CSO Officer and supervisor will also be involved in the short-term rental process. Administrator Gebert has been conducting training with the officers for the transition in completing those duties after her departure.

Squad 84 had deer damage repaired. Routine maintenance was done to the fleet in August.
