Rome Police Department Monthly Report December 2023

Meetings/Training Attended

During the month of December, I attended pan commission, and town board meetings. Officer Aldrich finished Emergency Medical Responder training.

Calls for Service, Citations, and Written Warnings

In December, officers handled 110 calls for service, issued 48 citations, and 41 written warnings.

Department Activities/Announcements

Sergeant Catie Jasin submitted her resignation from the P.D. effective January 5, 2024. She accepted a position with the Wisconsin Rapids Fire Department.

I would remind residents to be aware of ice conditions before deciding to go out on the ice. Open water is still present on the tri-lakes. In the past, we have had vehicles go through the ice on the lakes. Even with extended periods of cold weather, ice conditions have been poor on the channel between upper and lower Lake Camelot. Venturing out onto this channel ice is not recommended at any time.

I encourage citizens that leave the area for an extended time to stop at the Town Hall and complete a vacant home form. This form will allow us to contact you should anything happen at your property.

I would like to remind residents, that it is time to watch the conditions of the road carefully, while driving, and be aware of snow removal equipment on the roadways. State law requires the operator of any motor vehicle, that is not a snowplow, to remain at least 200 feet behind the snowplow, on roads with a speed limit of more than 35 MPH, and 75 feet behind on roadways posted at 35 MPH or less. The law also states if a snow plow is stopped at an intersection, the operator of any vehicle shall remain a minimum of 20 feet behind the snowplow, (out of the intersection) and shall remain stopped until the snowplow resumes motion.

Routine maintenance was done to the fleet in December.
