During the month of January, I attended Town Board meetings.

Calls for Service, Citations, and Written Warnings

Officers handled 115 calls for service, and issued 25 citations and 27 written warnings.

Department Activities/Announcements

Officer Matthews has informed me she has accepted a full-time position with the Plover Police Department. I will be working with the PFC to create an eligibility list.

The 2023 Boat Patrol claim of \$ 17,675.97 was submitted to the DNR. The DNR will audit the claim and we will receive reimbursement from the DNR of 70%-75% of the claim in early Spring.

One of the 2017 Ford Explorers required extensive mechanical repairs due to faulty fuel injectors. The vehicle remains out of service at this time. Routine maintenance was done to the remainder fleet in January.
