Meetings/Training Attended

During the month of March, I attended Town Board and various other town meetings.

Calls for Service, Citations, and Written Warnings

In March, officers handled 85 calls for service, issued 29 citations, and 26 written warnings.

Department Activities/Announcements

The 2023 annual report for the police department has been completed. It will be available to residents at the annual meeting and posted to the Town's web page.

One officer remains on FMLA leave due to a non-work-related injury. The officer is expected to be off thru May.

I am still working on filling open full-time vacancies, and putting the boat patrol roster together. The Town Board approved a full-time sign on bonus program to help with recruitment. They also increased part-time wage to a range of \$ 25.00 thru \$ 31.00 per hour. This should help with both recruitments.

Vehicle Fleet/Maintenance

The police department received two new 2024 Ford Explorers. Equipment will be ordered for the upfit of the vehicles and they should be in service by early summer. Routine maintenance was done to the fleet in March.
