Rome Police Department Monthly Report June 2025

Meetings/Training Attended

During the month of June, I attended PFC, Tracs, and Motorola Flex Software meetings. Officer Aldrich and I also attended a table top exercise at the Adams Community Center.

Calls for Service, Citations, and Written Warnings

In June officers handled 177 calls for service, issued 38 citations, and 24 written warnings. The boat patrol logged 126 hours of patrol, issuing 2 citations, and 13 written warnings.

Department Activities/Announcements

I would remind boaters to ensure they have read the current boating law pamphlet and are following it prior to hitting the water this summer. The regulations are in place to ensure everyone's safety on our lakes.

We have been receiving complaints of boat traffic and water skiing after 8:00 pm on Lakes Camelot, Sherwood, and Arrowhead. As a reminder these lakes are all slow no wake after 8:00 pm. If residents observe boating violations on a routine basis, in a particular area, we urge them to call the Rome Police Department, so we can give these problem areas some extra attention.

The Rome Police Department will have a zero tolerance for illegal discharge of fireworks. A commonly used rule of thumb is that if the device explodes or leaves the ground it is unlawful to discharge without a permit. The permits issued at many roadside stands indicate a specific place for the discharge of the fireworks. NONE of those are in the Town of Rome so any discharge would be illegal and subject to a \$250.00 fine and confiscation of the fireworks.
