Rome Police Department Monthly Report July 2025

Meetings/Training Attended

During the month of July, I attended TraCS meetings for the software that is used to issue citations and complete crashes. I also completed the 2024-2025 annual recertification training reports that are required by the State of Wisconsin.

Calls for Service, Citations, and Written Warnings

In July officers handled 220 calls for service, issued 70 citations, and 33 written warnings. The Boat Patrol logged 135 hours of patrol, issued 10 citations, and 8 written warnings.

Department Activities/Announcements

Over the holiday weekend officers observed fireworks being discharged around the lakes. Again, I would like to continue to remind residents the Rome Police Department will have a zero tolerance for illegal discharge of fireworks. If you are caught discharging them expect to be cited. A commonly used rule of thumb is that if the device explodes or leaves the ground it is unlawful to discharge without a permit. The permits issued at many roadside stands indicate a specific place for the discharge of the fireworks. NONE of those are in the Town of Rome so any discharge would be illegal and subject to a \$250.00 fine.

On July 12, 2025, Visit Rome and Up North Brewing Company sponsored the second "Dash with the Dogs" event. The event raised \$ 1,528.
