## Rome Police Department Monthly Report December 2025

### **Meetings/Training Attended**

During the month of December, I attended Management Group, Adams County Emergency Detention, Adams County Animal Control Procedures, and Town Board meetings.

### **Calls for Service, Citations, and Written Warnings**

During the month, officers handled 98 calls for service, issued 37 citations, and 40 written warnings.

### **Department Activities/Announcements**

Officer Warnecke completed phase two of the field training program during December. The program has four phases of training. I would anticipate the end of field training to be in early February.

I encourage citizens that see suspicious activity to report the situation to the police department as soon as they witness it. Many times, our residents and visitors delay calling the police figuring what they saw is minor and may be nothing so it can wait. Officers are told the witness didn't want to interrupt an Officer in the middle of the night. The Rome Police Department is staffed 24 hours a day 365 days a year. I would encourage our residents and visitors to report things immediately regardless of the time of day or night. Non-emergency reports should be reported to the Adams County Dispatch at 608-339-3304 option 0. As always emergencies should be reported to 911.

The police department would also like to remind those who may be leaving property, for an extended period of time, to fill out a vacant home form before leaving. The form can be picked up at the Police Department or printed from the Town web site. This helps the Police Department to be aware of properties in town that are vacant, and gives us accurate contact information for property owners in the event we would need to contact them.
