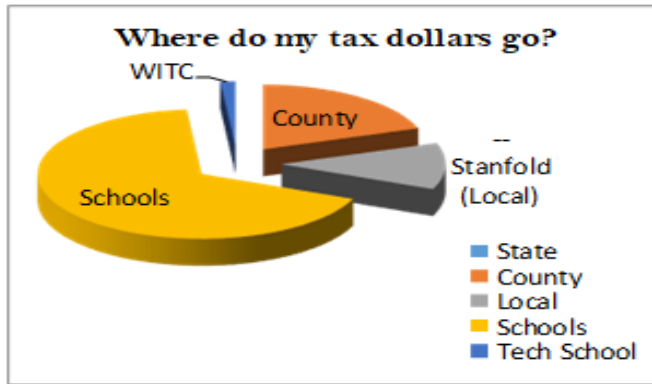


# STANFOLD NEWSLETTER 2024

- **Snow Plowing** – State law prohibits plowing snow across town roads from driveways. It is a safety hazard for the snowplow driver and equipment; violators may be fined and liable for damages.
- **Mailbox Requirements** –

- **Burning Permits** - Snow on the ground- no permit required. No snow - call the Town Chairman for a permit, no charge. You will then need to call the Barron Co. Sheriff's Department at 715-537-3106.
- **Sand/salt** - is available at the Town Shop for residents no charge if they need a pail or two.
- **Fire Calls** – Homeowners/Landowners are required to pay for 100% of costs for fire fighters and truck costs for every fire call to their property.
