- * A Board member read the minutes of the Regular Meeting held on Monday, September 8, 2025. Jennifer Guslick made a motion to accept the minutes as read. Motion was seconded by Chad Dhein. Motion carried.

 - Insurance Coverage Discussion Chad Ciardo went through the town insurance policy and discussed ways to limit the town's exposure to risk and potential changes and improvements to our policy. He will investigate questions posed regarding our coverage with the insurance underwriters and report back.
 - o Advisory Resolution Discussion on this item is tabled until a future town meeting.
 - Renew Contract with Schultz Appraisal Chad Dhein made a motion to approve the renewal of Schultz Appraisal contract. Motion was seconded by Jennifer Guslick. Motion carried.
- * Continued Discussion:
 - Road and Concerns Received first and final invoice from Rockfield Rd. ARIP project. Additional discussion with Village of Germantown regarding previous ARIP grants and communication with them on the possibility of doing future additional shared project grants for road improvement projects, such as Cedar Lane. Discussion regarding replacement of the washed-out culvert on Pioneer Road. We've requested diggers hotline information on the area and discussed the scope of the project with FEMA and the county. We are investigating options with neighboring municipalities to reduce the cost of the project by pooling resources. It was proposed to delay voting on approval of the grant payment from tonight's meeting to tomorrow's special budget workshop meeting under Item 6: "Discuss any other business authorized by law."
 - On October 14, 2025, Chad Dhein made a motion to pay the Town's responsibility for the ARIP project. Motion was seconded by Jennifer Guslick. Motion carried.
 - Solar Panel Road Agreement The Board is waiting to receive an updated version of the Road Agreement from One Energy and the Village of Germantown.
 - Adopt Record Management System Discussion on this item is tabled until the next regular town meeting.
