Town of Bayfield, Wisconsin Pikes Creek Trail Footbridge Project Bid Proposals Due: by 3 p.m. February 7, 2023

Request for Bid Proposals: The Town of Bayfield, WI is accepting bid proposals for the design, manufacture, delivery, and possible installation of a footbridge, 55' x 5', across Pikes Creek. Bids must be received by email to bayfieldtownclerk@centurytel.net or in person at 85450 County Highway J, Bayfield, WI 54814, on or before the closing date and time indicated above. Office Hours are Tuesdays 8AM-4PM. A drop box is also available.

Project and Site Description: The bridge will be located on Department of Natural Resources-managed land adjacent to the Les Voigt State Fish Hatchery at 83875 State Highway 13, Bayfield, Wisconsin 54814. Vehicle access is available to the bridge location via the Red Dam Access Road, approximately 325 feet beyond the gate across the road (see maps).

The bridge site is located in a straight and deep-channeled section of the creek with high stable banks. The Soils are classified as Moquah Fine Sandy Loam.

The bridge foundation/footings will be set approximately 6 feet back from the bank edge on either side of the creek to ensure long-term stability from potential bank erosion. This Wisconsin Dept of Natural Resources (DNR) managed property (a priority fisheries creek and watershed) does not allow for the excavation of soil, driving piles, or significant anchors penetrating the soil. A prefab concrete pad or treated timbers, secured by steel rods driven to a depth up to 5 ft. deep would be acceptable footings. Equipment access for the foundation and bridge placement is limited to one-side-of-the-creek-via the-Red Dam Access Road Service.

• By February 21, 2023: Contract and Notice to Proceed issued.

The selected contractor is encouraged to visit the site to verify the field dimensions and logistics for accurate pricing. [Note: There is no project contingency fund if the work exceeds the bid proposal.]

June – July 2023

- Contractor delivers bridge to site.
- Contractor installs the bridge, if this is included in the contract award.
- Work to be completed no later than August 15, 2023


