ORDINANCE

-To Re-Adopt Town Ordinance to Establish Penalty for Violation of Town Ordinances and to Re-Adopt Town Ordinance Adopting §175.25, Wis. Stats., by Reference—

THE TOWN BOARD OF THE TOWN OF BLOOMER HEREBY ORDAINS AS FOLLOWS:

Section One: That for reason of technical non-compliance with the literal requirement of §60.80(1), Wis. Stats., in the publication of ordinances adopted by the Town Board on July 5, 2010, which ordinances established a penalty for violation of Town ordinances and adopted §175.25, Wis. Stats., by reference, which publication is required within thirty (30) days of the date of adoption of ordinances, the Town Board hereby intends to re-adopt the said ordinances and to instruct the Town Clerk to comply with the requirements of §60.80(1), Wis. Stats.

Section Two: That the Town Board hereby re-adopts the attached ordinance, entitled "General Penalty for Violation of Town Ordinances," Exhibit "A" to this Ordinance.

Section Three: That the Town Board hereby re-adopts the attached ordinance, entitled "Storage of Junked Motor Vehicles, Incorporating §175.25, Wis. Stats., By Reference," Exhibit "B" to this Ordinance.

Section Four: That this Ordinance shall take effect upon its adoption and publication as required by law.

Section Five: That the Town Clerk shall effect compliance with §60.80(1) and (2), Wis. Stats., by publishing complete copies of each of the ordinances re adopted under this Ordinance, together with a copy of this Ordinance within thirty (30) days of the date of adoption of this Ordinance, said publication to be in the Bloomer Advance. In addition, the Clerk shall post copies of the said ordinances and this Ordinance at three (3) places in the Town likely to give the public notice hereof. The Clerk shall file her affidavit of posting as a permanent record of the Town.



ORDINANCE

-General Penalty for Violation of Town Ordinances-
