## **Operator's License Information The Town of Boulder Junction**

The Town of Boulder Junction, by Town Ordinance # 2-95 and by State Statutes Chapter 125 regulates the sale, procurement and dispensing of alcoholic beverages.

No person, except as provided by 125.06 Wis. Stats., shall within the Town of Boulder Junction, serve, sell, manufacture, rectify, brew, or engage in any other activity for which the town Ordinance or Chapter 125, Wis. Stats., requires a license, permit, or other authorization without holding the appropriate license or permit. Specifically, an Operator's License is required by Wis. Stats. 125.17(1),125.32(2) and 125.68(2).

The following is an Application for an Operator's License, and must be completed truthfully and in its entirety and sworn before the Clerk, or a Notary Public. The form must be submitted to the clerk along with the fee, and be on file in her office at least fifteen days before approval may be granted by the Town Board of Supervisors of the Town of Boulder Junction. The applicant must show proof of attendance at a Responsible Server Beverage Training Course. Applicants are exempt from this class if they can provide proof of an Operator's, a Manager's or Retail License within the last two years, or can show proof of attendance of the class within the last two years. An applicant applying for renewal of an existing Operator's License is exempt from the training class.

A background check is required for **ALL** applicants. The background check will be done in complete confidence by the Police Department. <u>Results may be shared with the Town Clerk</u> <u>and/or Town Board</u>. Any background check revealing the applicant's failure to meet statutory guidelines may result in non-issuance of the license.

An applicant must be 18 years or older. A temporary or Provisional Operator's License may be issued for those enrolled in the Responsible Server's course. The temporary license is issued only once, and for a period of up to thirty days. Regular Operator's Licenses may be issued for a two (2) year period, with the License Period running from July 1-June  $30^{\text{th}}$  of each year. All Licenses expire on the <u>30<sup>th</sup> of June in even number years</u>, regardless of when issued throughout the year.

Fees for the Licenses are as follows: Provisional License-\$1.00 First-time Application Operator's License-\$27.00 (includes charge for background check). Renewal – Two Year Operator's License - \$27.00

Please fill out the form carefully, and ensure that the owner of the establishment at which you will be working signs the form, verifying your employment with his/her establishment. Remember to have the application signed and sworn to the clerk or a Notary Republic.

I understand that said application is subject to an acceptable background check, receipt of responsible beverage course certification (unless application meets the requirements for renewal), and receipt of fee paid to the Town Treasurer. This application is also subject to a <u>15-day waiting period</u> from the time that said application is filed with the Town Clerk prior to consideration by the Town Board. If the license is approved by the Town Board, it shall expire on <u>June 30 of this year (if even numbered year) or the earliest even numbered year</u> for a maximum length of up to 2 years.
