A RESOLUTION APPROVING THE 2015 BUDGET INCLUDING ELECTORS AUTHORIZATION TO EXCEED HIGHWAY EXPENDITURES AND THE TOWN LEVY FOR THE TOWN OF BOULDER JUNCTION

WHEREAS, the Town of Boulder Junction Electors approved the tax levy pursuant to Section 60.10(1)(a) of the Wis. Stats., representing a 15.06% tax levy increase, at the Special Electors Meeting held on December 2, 2014; and

WHEREAS, the Town of Boulder Junction Electors approved the 2015 highway expenditures, pursuant to Sec. 81.01(3) of the Wis. Stats.; and

WHEREAS, the Town of Boulder Junction Electors voted favorably to exceed the statutory yearly limit for the construction, maintenance and repair of town highways and bridges by authorizing by resolution to set the town's road budget for 2015 at \$673,682.24, pursuant to Sec. 82.03(2) of the Wis. Stats.; and

WHEREAS, the Town of Boulder Junction Electors voted favorably to issue up to 2.3 million dollars in general obligation bond for the construction of a new Community Center and Library bringing a total levy for the 2015 Budget for the Town of Boulder Junction to \$908,000.00.

NOW, THEREFORE, BE IT RESOLVED, that this resolution, adopted by a 2/3 majority roll call vote of the membership of the Town Board with a quorum present, hereby approves the 2015 Budget, as follows:
