Board meeting for the Town of Breed was called to order by Chairman Phil Christenson. Open meeting notice was satisfied.

Pledge of allegiance.

Chairman Christenson, Supervisors Mark Quandt and Ahren Telford, Clerk Kristen Telford present. Treasurer Ethel Firgens absent.

Review made of the agenda. Motion to accept the agenda made by A. Telford, seconded by Quandt. 3 ayes. Carried.

Review made of the August 12<sup>th</sup>, 2025 regular meeting minutes. Motion to approve minutes made by Christenson, seconded by Quandt. 3 ayes. Carried. Review made of the August 13<sup>th</sup>, 2025 special meeting. Motion to approve the minutes made by A. Telford, seconded by Quandt. 3 ayes. Carried.

Clerk Telford gave an update on Treasurer Firgens reason for absence and timeframe of return then gave the expenditures and receipts report for the month of August showing a balance of \$52,637.87 in checking and \$162,219.95 in the money market. Motion to accept the expenditure/receipts report made by Christenson, seconded by Quandt. 3 ayes. Carried.

Public Input- Weso Creek sign needs replacing. Neighbor on Weso Creek Rd having issues with the County over survey lines and timber harvested off contested land. Question: Are we getting Spectrum?

Plan Commission discussed the issue of Lynn Court and recommended its discontinuation. Motion to approve the Plan Commission's recommendation to discontinue Lynn Court made by Quandt, seconded by A. Telford. 3 ayes. Approved.

Northern Oconto County Community Officer (NOCCO)- The Seven Towns intends to form a committee to explore options of enforcing town ordinances. They are asking that each board appoint someone to the committee. Motion to appoint Phillip Christenson to the NOCCO committee for the Town of Breed made by A. Telford, seconded by Quandt. 2 ayes, 1 abstain. Carried.

R&R Assessing Contract- Renewal contract was submitted to perform maintenance for 2026-2029 now that the Town is in compliance with assessed values with the Dept of

Revenue. Motion to renew contract with R&R Assessing made by Christenson, seconded by A. Telford. 3 ayes. Carried.

COM2 Contract- Previous contract was a 6 month trial contract of services to recycle electronics. Motion to renew the contract for 1 year with COM2 Recycling made by A. Telford, seconded by Quandt. 3 ayes. Carried.

Road Report- Tom Davis to start this week. Logan bridge was surveyed but have not reported back with info. Town employee to manage sign repair and brushing. Patching done on E. Anderson Lake Ln( 3 patches), Wendt Rd(2 patches), Spreeman Rd(2 patches), Heise Rd(5 patches). Will do more patching and crack sealing as budget allows.

Recycle Center- Pat LeBlanc has retired. James Telford will manage the recycling center. Hole in fence mended to keep ATVs out. Motion to raise James Telford's wage from \$13 to \$15/hr made by Christenson, seconded by Quandt. 2 ayes, 1 abstain. Carried.

Motion for Ahren Telford to help at the recycle center on Saturdays until the big dumpsters are gone made by Christenson, seconded by Quandt. 2 ayes, 1 abstain. Carried.

Updates- PSC grant check has been mailed out from the state to reimburse for the HVAC and lighting at the Community Center. Chairman applied for a TC Energy grant for an AED defibrillator, dechoker, and first aid kits. Grant was approved. Gillett Ambulance will provide training on how to use the AED and perform layman's CPR. Room Tax Commission working on targeting areas where most tourists to the area live. Majority from Milwaukee, Green Bay, Fox Valley, Chicago, and Madison.

Review and pay monthly bills. Motion to pay bills made by Christenson, seconded by A. Telford. 3 ayes. Carried.

Meeting adjourned at 7:59PM.
